RESOLUTION NO. 2026 -**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING UTILIZATION OF THE ST. JOHNS COUNTY SCHOOL DISTRICT BID #2022-16 AGREEMENT WITH BLISS PRODUCTS AND SERVICES INC. TO PROVIDE RESURFACING OF THE PLAYGROUND AT OB JOHNSON PARK FOR A NOT TO EXCEED AMOUNT OF ONE HUNDRED, THIRTY-EIGHT THOUSAND, THREE HUNDRED AND EIGHTY-ONE DOLLARS (\$138,381); AND PROVIDING AN EFFECTIVE DATE.**

17           **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances,  
18 Section 23-9, Award, (e), the City Manager may award procurements within the  
19 delegated spending authority, and all other procurements, except emergency  
20 procurements, require commission approval for award; and  
21

22           **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances,  
23 Section 23-5 (4) Piggybacking, the City may procure goods or services from  
24 vendors who have been selected as a result of a competitive selection process by  
25 another governmental entity if the selection process utilized by the contracting entity  
26 was substantially similar to the requirements of the City, and the goods or services  
27 procured by the City are procured pursuant to the original contract scope and terms;  
28 and

30           **WHEREAS**, City of Hallandale Beach Parks amenities were inspected and the  
31 OB Johnson Park playground surface replacement project was initially slated for  
32 FY2027; however, Staff recommends that the playground surface be replaced in  
33 FY2026 due to the deteriorated condition, as it now presents a safety hazard and the  
34 playground is closed until the resurfacing takes place; and  
35

36           **WHEREAS**, Bliss Products and Services Inc. has proposed to provide the  
37 playground resurfacing for a not to exceed amount of One Hundred, Thirty-Eight

38 Thousand, Three Hundred and Eighty-One Dollars (\$138,381) utilizing the St. Johns  
39 County School District Bid #2022-16 Agreement; and

41 **WHEREAS**, Staff recommends that the Mayor and City Commission find it to  
42 be in the public interest to authorize utilization of the competitively solicited St. Johns  
43 County School District Bid #2022-16 Agreement with Bliss Products and Services  
44 Inc.to provide resurfacing of the playground at OB Johnson Park for a not to exceed  
45 amount of One Hundred, Thirty-Eight Thousand, Three Hundred and Eighty-One  
46 Dollars (\$138,381), and authorize the City Manager to execute relating documents.

48 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
49 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

51 **SECTION 1.** The foregoing “Whereas” clauses are incorporated herein.

53 **SECTION 2. City Manager Authorization.** The Mayor and City  
54 Commission hereby authorize utilization of the competitively solicited St. Johns  
55 County School District Bid #2022-16 Agreement with Bliss Products and Services  
56 Inc.to provide resurfacing of the playground at OB Johnson Park for a not to exceed  
57 amount of One Hundred, Thirty-Eight Thousand, Three Hundred and Eighty-One  
58 Dollars (\$138,381), and authorize the City Manager to execute relating documents.

59

60 **SECTION 3. Effective Date.** This Resolution shall take effect  
61 immediately upon its passage and adoption.
