WHEREAS, the Hallandale Beach Community Redevelopment Agency (the "HBCRA") desires that the City of Hallandale Beach (the "City") provide certain direct services consisting of community policing innovations to the HBCRA for Fiscal Year 2024-2025; and

WHEREAS, Section 163.400, Florida Statutes, known as Cooperation by Public Bodies, encourages municipalities to do any and all things necessary to aid or cooperate in the planning or carrying out of a community redevelopment plan and related redevelopment activities; and

WHEREAS, the Board of Directors of the HBCRA desires to approve the Interlocal Agreement relating to the provision of direct services consisting of community policing innovations by the City to the HBCRA for Fiscal Year 2024-2025, in substantially the form attached hereto as Exhibit "A" and by this reference made a part hereof in an amount not to exceed One Million Eight Hundred Twenty Six Thousand Two Hundred Thirty Seven and 00/100 (\$1,826,237.00), which includes include funding for the Strategic Intelligence Unit (SIU), departmental training to promote positive interactions between the community and police, and the addition to the City LPR/CCTV infrastructure.

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:
