2 RESOLUTION NO. 2026 -

3 A RESOLUTION OF THE CITY COMMISSION OF THE  
4 CITY OF HALLANDALE BEACH, FLORIDA,  
5 SUPPORTING THE SUBMITTAL OF A ROADS FOR  
6 ECONOMIC VITALITY PRE-CYCLE 1 APPLICATION  
7 TO THE BROWARD METROPOLITAN PLANNING  
8 ORGANIZATION FOR FUNDING OF UP TO FIVE  
9 MILLION DOLLARS (\$5,000,000) FOR THE NW/SW  
10 8TH AVENUE COMPLETE STREETS AND MOBILITY  
11 IMPROVEMENTS PROJECT; COMMITTING TO  
12 PROJECT DELIVERY, FUNDING, AND  
13 MAINTENANCE RESPONSIBILITIES; AND  
14 PROVIDING FOR AN EFFECTIVE DATE.

15 WHEREAS, the Broward Metropolitan Planning Organization (MPO)  
16 administers the Roads for Economic Vitality (REV) Program to fund transportation  
17 projects that enhance safety, mobility, resiliency, and economic development; and

18 WHEREAS, the REV Pre-Cycle 1 application provides an opportunity for  
19 municipalities to compete for funding of up to Five Million Dollars (\$5,000,000.00) for  
20 eligible transportation improvements; and

21 WHEREAS, the City of Hallandale Beach seeks to submit a REV Pre-Cycle 1  
22 application for the NW/SW 8th Avenue Complete Streets and Mobility Improvements  
23 Project (Project No. M2015), located from County Line Road to Pembroke Road; and

24 WHEREAS, the proposed project includes roadway reconstruction,  
25 multimodal enhancements, continuous sidewalks, bicycle facilities, ADA-compliant  
26 curb ramps, drainage improvements, traffic calming measures, and safety upgrades  
27 along approximately 1.54 miles of corridor; and

28 WHEREAS, the project is consistent with the City's goals for improving  
29 transportation safety, enhancing multimodal connectivity, supporting economic  
30 activity, and increasing system resiliency; and

31 WHEREAS, submission of the REV application requires formal support from  
32 the City Commission to demonstrate project commitment, eligibility, and readiness  
33 for implementation; and

34           **WHEREAS**, the City of Hallandale Beach commits to implementing the project in  
35 accordance with MPO, State, and Federal requirements, including coordination with  
36 applicable agencies; and

37           **WHEREAS**, the City of Hallandale Beach acknowledges that the REV  
38 Program may require local matching funds, upfront project costs, and ongoing  
39 maintenance responsibilities; and

40           **WHEREAS**, upon completion, the City of Hallandale Beach shall be  
41 responsible for maintaining the project improvements or coordinating such  
42 maintenance as required.

43   **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**  
44   **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

45   **SECTION 1.** The foregoing “WHEREAS” clauses are hereby ratified and  
46 incorporated as the legislative intent of this Resolution.

47   **SECTION 2.** The City Commission hereby resolves its support for the submittal of a  
48 Roads for Economic Vitality (REV) Pre-Cycle 1 application to the Broward  
49 Metropolitan Planning Organization (MPO) for funding of up to five million dollars  
50 **(\$5,000,000)** for the NW/SW 8th Avenue Complete Streets and Mobility  
51 Improvements Project (Project No. M2015).

52   **SECTION 3.** The City Commission hereby authorizes the City Manager to submit  
53 the REV application and execute all necessary documents, certifications, and  
54 agreements required for participation in the program.

55   **SECTION 4.** The City of Hallandale Beach commits to funding, implementation, and  
56 delivery of the project, including any required local match, upfront costs, and  
57 compliance with all applicable MPO, State, and Federal requirements.

58   **SECTION 5.** The City of Hallandale Beach agrees to maintain or coordinate the  
59 maintenance of all project improvements upon completion.

60 **SECTION 6. Effective Date.** This Resolution shall take effect immediately upon its  
61 passage and adoption.
