22	cracks, sinkholes, and unstable road conditions within the City, requiring a large-scale
23	operation to perform road rehabilitation; and

25	WHEREAS, while internal staff routinely maintains streets, sidewalks, and signages
26	throughout the city, it is inadequately staffed and equipped to undertake milling and
27	resurfacing of major roads and bridges on a large scale; and

. 29	WHEREAS, on September 14, 2023, the City released Bid No. FY 2022-2023-019 -
3 0	Roadway Restoration and Repair; and

32	WHEREAS, City plans to utilize the agreement with Roadway Restoration and Repair
33	to M&M Asphalt Maintenance, Inc – DBA All County Paving, as the lowest responsive bidder,
34	for a term of one year in the amount of One Million Five Hundred Thousand Dollars
35	(\$1,500,000) for Fiscal Year 2023-24, with up to 4 subsequent potential yearly contract
36	extensions for restoration and repair to be reviewed during the annual operating budget
