4 **A RESOLUTION OF THE MAYOR AND CITY COMMISSION**
5 **OF THE CITY OF HALLANDALE BEACH, FLORIDA,**
6 **AUTHORIZING AWARD OF BID # NO. FY 2022-2023-019 -**
7 **ROADWAY RESTORATION AND REPAIR TO M&M**
8 **ASPHALT MAINTENANCE, INC – DBA ALL COUNTY**
9 **PAVING AS THE LOWEST RESPONSIVE BIDDER IN AN**
10 **AMOUNT NOT TO EXCEED THREE MILLION FIVE**
11 **HUNDRED THOUSAND DOLLARS (\$3,500,000); AND**
12 **PROVIDING AN EFFECTIVE DATE.**

15 **WHEREAS,** pursuant to Chapter 23, Section 23-4, City of Hallandale Beach Code of
16 Ordinances, purchases of and contracts for equipment, supplies, and contractual services,
17 when the estimated cost shall exceed \$50,000.00, except as specifically provided in that
18 section, shall be based, wherever possible, on competitive bids Code of Ordinances, Code
19 of Ordinances, Code of Ordinances; and

20
21 **WHEREAS,** poor weather conditions and frequent traffic continuously create potholes,
22 cracks, sinkholes, and unstable road conditions within the City, requiring a large-scale
23 operation to perform road rehabilitation; and

24
25 **WHEREAS,** while internal staff routinely maintains streets, sidewalks, and signages
26 throughout the city, it is inadequately staffed and equipped to undertake milling and
27 resurfacing of major roads and bridges on a large scale; and

28
29 **WHEREAS,** on September 14, 2023, the City released Bid No. FY 2022-2023-019 -
30 Roadway Restoration and Repair; and

31
32 **WHEREAS,** City plans to utilize the agreement with Roadway Restoration and Repair
33 to M&M Asphalt Maintenance, Inc – DBA All County Paving, as the lowest responsive bidder,
34 for a term of one year in the amount of One Million Five Hundred Thousand Dollars
35 (\$1,500,000) for Fiscal Year 2023-24, with up to 4 subsequent potential yearly contract
36 extensions for restoration and repair to be reviewed during the annual operating budget

37 process for the Fiscal Years 2025-28 in an amount not to exceed Five Hundred Thousand
38 Dollars (\$500,000) per year, and authorize the City Manager to execute all relating
39 documents.



41 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
42 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

44 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

46 **SECTION 2.** The Mayor and City Commission hereby award Bid No. FY 2022-2023-
47 019 - Roadway Restoration and Repair to M&M Asphalt Maintenance, Inc – DBA All County
48 Paving as the lowest responsive bidder in the amount of One Million Five Hundred Thousand
49 Dollars (\$1,500,000) for Fiscal Year 2023-24 with up to 4 subsequent potential one year terms
50 approved at the discretion of the City Manager for Fiscal Years 2025-28 in an amount not to
51 exceed Five Hundred Thousand Dollars (\$500,000) per year, subject to appropriations, and
52 authorize the City Manager to execute all relating documents.

54 **SECTION 3.** This Resolution shall take effect immediately upon its passage and
55 adoption.
