RESOLUTION NO. 2024 -**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING ENTERING INTO BROWARD COUNTY INTERLOCAL AGREEMENT FOR OPTIONAL SERVICES BULK TRASH AND YARD WASTE DROP-OFF PROGRAM THROUGH SEPTEMBER 30, 2026, WITH AUTOMATIC RENEWALS FOR THREE (3) ADDITIONAL ONE-YEAR TERMS EXPIRING ON SEPTEMBER 30, 2029, IN A NOT TO EXCEED ANNUAL AMOUNT OF SIXTY-EIGHT THOUSAND, EIGHT HUNDRED AND THIRTY-TWO DOLLARS (\$68,832); AND PROVIDING FOR AN EFFECTIVE DATE.

16 **WHEREAS**, pursuant to Sec. 23-12 of the City of Hallandale Beach Code of
17 Ordinances, the purchase of services in excess of \$50,000 shall be approved by the City
18 Commission and pursuant to Section 23-6 of the City of Hallandale Beach Code of
19 Ordinances, the City Manager shall have the authority to recommend to the City Commission
20 award of contracts; and

22 **WHEREAS**, on August 28, 2012, the Board of County Commissioners approved the
23 formation of an Interlocal Agreement to allow municipalities in Broward County to use County
24 services for Keep Broward Beautiful, Household Hazardous Waste, and Bulk Trash and Yard
25 Waste programs on a per capita fee-for-service basis; and

27 **WHEREAS**, the existing ILA was approved through Resolution No. R-2019-065 and
28 allows residents to drop-off Bulk Trash and Yard Waste at permanent locations, but is set to
29 expire after its final renewal term on September 30, 2024; and
30

31 **WHEREAS**, Staff recommends that the Mayor and City Commission of the City of
32 Hallandale Beach find it in the public interest to authorize entering into Broward County's
33 Interlocal Agreement for Optional Services Bulk Trash and Yard Waste Drop-Off program
34 through September 30, 2026, with automatic renewals for three (3) additional one-year terms
35 expiring on September 30, 2029, in a not to exceed annual amount of Sixty-Eight Thousand,
36 Eight Hundred and Thirty-Two Dollars (\$68,832), and authorize the City Manager to execute
37 relating documents.

38 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
39 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

41 **SECTION 1. Whereas Clauses.** The foregoing “Whereas” clauses are incorporated
42 herein.

44 **SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby
45 authorize entering into Broward County’s Interlocal Agreement for Optional Services Bulk
46 Trash and Yard Waste Drop-Off program through September 30, 2026, with automatic
47 renewals for three (3) additional one-year terms expiring on September 30, 2029, in a not to
48 exceed annual amount of Sixty-Eight Thousand, Eight Hundred and Thirty-Two Dollars
49 (\$68,832), and authorize the City Manager to execute relating documents.

51 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
52 passage and adoption.
