20	Six Cents (\$26,419.46), which the City seeks to settle subject to commission approval; and

22	WHEREAS, pursuant to Chapter 24, Section 24-3(d) of the City of Hallandale Beach
23	Code of Ordinances, proposed settlements in excess of \$20,000.00 shall be submitted to the
24	City Commission for its decision; and

26	WHEREAS, the Mayor and City Commission, being fully advised of the facts of this
27	matter, believe it is in the best interest of the City to resolve this matter and accepts the
28	proposal for settlement.

30	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
31	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

33	<b>SECTION 1.</b> The foregoing "Whereas" clauses are confirmed as true and
