A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED REQUEST FOR PROPOSAL #FY2021-2022-007, CONSULTANTS' COMPETITIVE NEGOTIATION ACT (CCNA) DESIGN OF DEPARTMENT OF PUBLIC WORKS (DPW) ELECTRIC VEHICLE (EV) BUS CHARGING AND FLEET FACILITIES, TO THE HIGHEST RANKED VENDOR, SALTZ MICHELSON ARCHITECTS, INC., OR IN EVENT NEGOTIATIONS DO NOT SUCCEED, TO THE SECOND HIGHEST RANKED VENDOR, FOR A NOT TO EXCEED AMOUNT OF SEVEN HUNDRED THOUSAND DOLLARS (\$700,000); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on June 15, 2022, through Resolution No. 2022-065, the City Commission approved an electric vehicle (EV) bus fleet and charging facilities purchase in an amount Not to Exceed Five Million, Nine Hundred Seventy-Two Thousand, Seven Hundred Ninety-Seven Dollars and Seventeen Cents (\$5,972,797.17); and

WHEREAS, infrastructure for the electric vehicle (EV) bus fleet and charging facilities is required, and design and construction of the facilities will enable the city to not only take advantage of multiple sources of grant funding, but also to continue providing free bus services for the residents; and

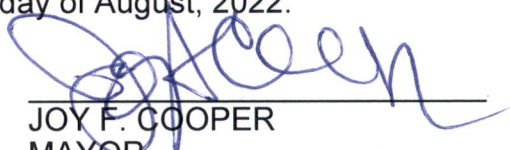
WHEREAS, Staff recommends that the Mayor and City Commission approve the award of RFP# FY2021-2022-007, Consultants' Competitive Negotiation Act (CCNA) Design of Department of Public Works (DPW) Electric Vehicle (EV) Bus Charging and Fleet Facilities, to the highest ranked vendor, Saltz Michelson Architects, Inc., and authorize the City Manager and City Attorney to negotiate and execute an agreement for an amount Not to Exceed Seven Hundred Thousand Dollars (\$700,000), and should negotiations with the highest ranked firm not succeed, authorize the City Manager and City Attorney to negotiate and execute an agreement with the second highest ranked firm, CPZ Architects, Inc, for a Not to Exceed amount of Seven Hundred Thousand Dollars (\$700,000).

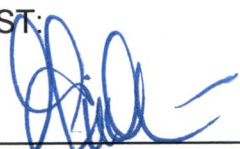
