A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
AUTHORIZING UTILIZATION OF COOPERATIVE  
SOURCEWELL AGREEMENT TO PURCHASE VEHICLE  
REPAIR PARTS, ON AN AS NEEDED BASIS, FROM  
AUTHORIZED DEALER PAI HOLDCO, INC. DBA PARTS  
AUTHORITY LLC IN AN AMOUNT NOT TO EXCEED ONE  
HUNDRED AND TEN THOUSAND DOLLARS (\$110,000), FOR  
FY 2025-26; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section Award, (e), the City Manager may award procurements within the delegated spending authority, and all other procurements, except emergency procurements, require commission approval for award; and

**WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section Competitive procurement required; Procurement Mechanisms, Subsection (3) Cooperative Purchasing, the City may procure goods or services through a variety of agreements whereby two or more public entities have the opportunity to purchase from one supplier or multiple suppliers using a single competitive procurement mechanism, subsection (4) Piggybacking, the City may procure goods or services from vendors have been selected as a result of a competitive selection process by another governmental entity if the selection process utilized by the contracting entity was substantially similar to the requirements of the City, and the goods or services procured by it are procured pursuant to the original contract scope and terms; and

**WHEREAS**, the City of Hallandale Beach Department of Public Works – Fleet Maintenance Division services and repairs vehicles for the Police Department, Code Compliance, and Recreation, Human Services, and Public Works; and

35                   **WHEREAS**, the City desires to utilize cooperative Sourcewell Master Agreement #080124  
36                   to purchase vehicle repair parts on an as needed basis, from authorized dealer PAI Holdco, Inc.,

37 DBA Parts Authority LLC, in an amount not to exceed One Hundred Ten Thousand Dollars  
38 (\$110,000), for FY 2025-26; and

40 **WHEREAS**, Staff recommends that the Mayor and City Commission authorize utilization  
41 of cooperative Sourcewell Master Agreement #080124 to purchase vehicle repair parts, on an  
42 as needed basis, from authorized dealer PAI Holdco, Inc., DBA Parts Authority LLC in an amount  
43 not to exceed One Hundred and Ten Thousand Dollars (\$110,000) for FY 2025-26, and authorize  
44 the City Manager to execute relating documents.

54 utilization of cooperative Sourcewell Master Agreement #080124 to purchase vehicle repair parts,  
55 on an as needed basis, from authorized dealer PAI Holdco, Inc., DBA Parts Authority LLC in an  
56 amount not to exceed One Hundred and Ten Thousand Dollars (\$110,000) for FY 2025-26 and  
57 authorize the City Manager to execute relating documents.

59 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
60 passage and adoption.
