4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
6 AUTHORIZING UTILIZATION OF COOPERATIVE  
7 SOURCEWELL AGREEMENT TO PURCHASE VEHICLE  
8 REPAIR PARTS, ON AN AS NEEDED BASIS, FROM  
9 AUTHORIZED DEALER PAI HOLDCO, INC. DBA PARTS  
10 AUTHORITY LLC IN AN AMOUNT NOT TO EXCEED ONE  
11 HUNDRED AND TEN THOUSAND DOLLARS (\$110,000), FOR  
12 FY 2025-26; AND PROVIDING FOR AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section  
16 23-9, Award, (e), the City Manager may award procurements within the delegated spending  
17 authority, and all other procurements, except emergency procurements, require commission  
18 approval for award; and

20 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section  
21 23-5 Competitive procurement required; Procurement Mechanisms, Subsection (3)  
22 Cooperative Purchasing, the City may procure goods or services through a variety of  
23 arrangements whereby two or more public entities have the opportunity to purchase from  
24 the same supplier or multiple suppliers using a single competitive procurement mechanism,  
25 and Subsection (4) Piggybacking, the City may procure goods or services from vendors  
26 who have been selected as a result of a competitive selection process by another  
27 governmental entity if the selection process utilized by the contracting entity was  
28 substantially similar to the requirements of the City, and the goods or services procured by  
29 the City are procured pursuant to the original contract scope and terms; and

31 **WHEREAS**, the City of Hallandale Beach Department of Public Works – Fleet  
32 Maintenance Division services and repairs vehicles for the Police Department, Code Compliance,  
33 Parks and Recreation, Human Services, and Public Works; and

35 **WHEREAS**, the City desires to utilize cooperative Sourcewell Master Agreement #080124  
36 to purchase vehicle repair parts on an as needed basis, from authorized dealer PAI Holdco, Inc.,

DBA Parts Authority LLC, in an amount not to exceed One Hundred Ten Thousand Dollars (\$110,000), for FY 2025-26; and

**WHEREAS**, Staff recommends that the Mayor and City Commission authorize utilization of cooperative Sourcewell Master Agreement #080124 to purchase vehicle repair parts, on an as needed basis, from authorized dealer PAI Holdco, Inc., DBA Parts Authority LLC in an amount not to exceed One Hundred and Ten Thousand Dollars (\$110,000) for FY 2025-26, and authorize the City Manager to execute relating documents.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1. Whereas Clauses.** The foregoing “Whereas” clauses are incorporated herein.

**SECTION 2. Authorization.** The Mayor and City Commission hereby authorize utilization of cooperative Sourcewell Master Agreement #080124 to purchase vehicle repair parts, on an as needed basis, from authorized dealer PAI Holdco, Inc., DBA Parts Authority LLC in an amount not to exceed One Hundred and Ten Thousand Dollars (\$110,000) for FY 2025-26 and authorize the City Manager to execute relating documents.

**SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its passage and adoption.
