RESOLUTION NO. 2025 -**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
AUTHORIZING THE RENEWAL OF 4:00 A.M. AND 6:00 A.M.  
NIGHTCLUB LICENSES FOR FISCAL YEAR 2025-2026 FOR  
THOSE BUSINESSES LISTED IN EXHIBIT A; PROVIDING  
FOR AN EFFECTIVE DATE.**

13       **WHEREAS**, in accordance with Section 5-9 of the City of Hallandale Beach ("City")  
14 Code of Ordinances (the "Code"), a person licensed under the provisions of the state  
15 beverage law may file an application with the City for a nightclub license to sell liquor, wine,  
16 and beer until the hours of either 4:00 a.m. or 6:00 a.m.; and

17       **WHEREAS**, pursuant to Section 5-9 (d) of the City's Code, all nightclub licenses shall  
18 expire at 11:59 p.m. on September 30 of each year unless previously renewed by the City  
19 Commission; and

20       **WHEREAS**, as provided for in Section 5-9 (d) of the City's Code, all current nightclub  
21 licenses shall be brought before the City Commission for consideration of renewal at the first  
22 regularly scheduled meeting in August of each year; and

23       **WHEREAS**, for Fiscal Year 2025-2026, there are seven (7) establishments seeking  
24 renewal of their nightclub license, as listed in Exhibit "A" attached hereto; and

25       **WHEREAS**, City staff has conducted inspections of the nightclub businesses seeking  
26 renewal and recommends that City Commission approve the renewal of the seven (7)  
27 nightclub licenses, subject to the conditions of approval set forth in Exhibit "A."

28       **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION**  
29 **OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

30       **SECTION 1. Recitals.** The foregoing "Whereas" clauses are incorporated  
31 herein.

32       **SECTION 2. Renewal of Nightclub Licenses for FY 25-26.** The Mayor and the City  
33 Commission approve the renewal of the seven (7) nightclub licenses with such conditions set  
34 forth in Exhibit "A".

**SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its passage and adoption.
