B. BEACH MANAGEMENT PROGRAM DISCUSSION. (STAFF: PARKS AND RECREATION DIRECTOR)

Parks and Recreation Director Cathie Schanz provided an overview of the item and answered questions posed by the Commission.

A motion was made by Commissioner Lazarow, seconded by Commissioner Butler to charge specific fees, including a \$30 per unit annual fee, a \$1000 application fee, and an amendment to include a \$5 chair fee instead of the per unit fee. The motion failed by the following vote:
