Good afternoon Director Odoms,

Emergency Repair at Lift Station 5

Due to the compromised wet well and the rotted pipe running through the structure, emergency repairs are required at Lift Station 5. The following is the detailed repair schedule, coordinated with Atlantic Pipe Services, with an estimated total repair cost of **\$60,000**:

Please note, **Atlantic Shores Blvd will be shut down** during the repair work on the scheduled dates provided.

• Monday (3/31):

 MOT (Maintenance of Traffic) setup and bypass installation will be handled by Atlantic Pipe Services. This will ensure proper traffic management around the work site and facilitate the bypass system needed for the repair work.

• Tuesday (4/1):

Divers arrive on-site to begin constructing the new pipe underwater. The divers will
work on the installation of a temporary system or the primary pipeline, depending on
the scope of the work required. They will be essential for any work below the water
level.

• Wednesday (4/2):

- Divers will remain on-site if further underwater work is required.
- WPB Crew will be on-site to clean the structure, perform a TV inspection to assess the condition of the pipes, and prepare for the subsequent lining process.
- Thursday (4/3):
 - CIPP (Cured-In-Place Pipe) Liner installation will take place. This process involves inserting and curing a new liner within the existing pipe to restore its integrity and prevent further damage. This will be a key step in ensuring the system's long-term functionality.
- Friday (4/4):
 - The bypass system and MOT will be removed, marking the completion of the repair process.

Estimated Repair Cost: \$60,000
