RESOLUTION NO. 2023- 003

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED HINTERLAND GROUP, INC. BID # FY2021-2022-022 LIFT STATION #3 REHABILITATION FOR AN AMOUNT OF TWO MILLION, TWO HUNDRED THOUSAND, TWO HUNDRED AND TWENTY DOLLARS (\$2,200,220), PLUS A 10% CONTINGENCY FOR A TOTAL NOT TO EXCEED AMOUNT OF TWO MILLION, FOUR HUNDRED TWENTY THOUSAND, TWO HUNDRED AND FORTY-TWO DOLLARS (\$2,420,242); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to the City of Hallandale Beach Code of Ordinances, Chapter 23, Section 23-4, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000, shall be based, wherever possible, on competitive bids; and

WHEREAS, Staff recommends rehabilitation of the City’s existing Lift Station #3 located at 3181 South Ocean Drive, Hallandale Beach, FL 33009 by replacing and upgrading mechanical and electrical equipment and installing a new emergency generator to improve system performance, increase system efficiency, and reduce system maintenance; and

WHEREAS, rehabilitation of Lift Station #3 will ensure the needs of increased development intensity are met, and will incorporate newer design standards granting easier access to the controls, valves, and pumps to significantly reduce the time and personnel required to perform regular maintenance, thereby reducing Operations and Maintenance costs; and

WHEREAS, while the total originally budgeted amount for this project was One Million, Eight Hundred Fifty-Seven Thousand, Nine Hundred and Fifteen Dollars (\$1,857,915), due to the current inflation costs of construction materials,

36 staff has requested additional funds in the amount of Five Hundred Sixty-Two
37 Thousand, Three Hundred and Twenty-Seven Dollars (\$562,327) to proceed with
38 construction in the first FY 2022-2023 Budget Amendment; and

40 **WHEREAS**, Bid # FY2021-2022-022 Lift Station #3 Rehabilitation was
41 released on September 19, 2022; and

43 **WHEREAS**, staff evaluated the responses and determined that Hinterland
44 Group, Inc. is the lowest responsive and responsible bidder; and

46 **WHEREAS**, staff recommends that the Mayor and City Commission award
47 Hinterland Group, Inc. Bid # FY2021-2022-022 Lift Station #3 Rehabilitation for an
48 amount of Two Million, Two Hundred Thousand, Two Hundred and Twenty Dollars
49 (\$2,200,220), plus a 10% contingency for a total not to exceed amount of Two
50 Million, Four Hundred Twenty Thousand, Two Hundred and Forty-Two Dollars
51 (\$2,420,242), and authorize the City Manager to execute any relating documents.

53 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE**
54 **CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

58 **SECTION 2.** The Mayor and City Commission hereby award Hinterland
59 Group, Inc. Bid # FY2021-2022-022 Lift Station #3 Rehabilitation for an amount of
60 Two Million, Two Hundred Thousand, Two Hundred and Twenty Dollars
61 (\$2,200,220), plus a 10% contingency for a total not to exceed amount of Two
62 Million, Four Hundred Twenty Thousand, Two Hundred and Forty-Two Dollars
63 (\$2,420,242), and authorize the City Manager to execute any relating documents.
