44 **WHEREAS**, Staff recommends that the Mayor and City Commission
45 authorize execution of a Work Authorization to retain the services of AECOM
46 Technical Services, Inc. to design the 18 Inch Force Main Along Layne Boulevard
47 Project in an amount Not-To-Exceed Two Hundred Eighty-One Thousand, Three
48 Hundred Twenty-Five Dollars and Two Cents (\$281,325.02) and authorize the City
49 Manager to sign all other related documents.

57 of a Work Authorization to retain the services of AECOM Technical Services, Inc.
58 to design the 18 Inch Force Main Along Layne Boulevard Project in an amount
59 Not-To-Exceed Two Hundred Eighty-One Thousand, Three Hundred Twenty-Five
60 Dollars and Two Cents (\$281,325.02) and authorize the City Manager to sign all
61 other related documents.




