WHEREAS, in order to receive surtax funding for the City Hall-005 Bus Shelter Improvements Project Construction Phase, the City Commission and the County Surtax Administration must approve a proposed interlocal agreement (ILA); and

WHEREAS, the Hall-005 Bus Shelter Improvements Project Construction Phase has been determined to be statutorily eligible for funding and has received subsequent approval for funding by the Broward County Board of County Commissioners; and

WHEREAS, the purpose of the Hall-005 Bus Shelter Improvements Project Construction Phase project specific ILA between the City and the County is to set forth the terms and conditions for the County to provide transportation surtax funding for the project and the terms and conditions for the municipality to complete the project; and

WHEREAS, the City Hall-005 Bus Shelter Improvements Project Construction 38 Phase is included in the City's 5-Year Capital Improvement Plan (CIP) program, and 39 was submitted to MAP Broward for surtax funding, requesting Three Million, One 40 Hundred, Thirty Thousand, Four Hundred and Fifty-Three Dollars and Fifty-Four Cents 41 (\$3,130,163.54) towards the Construction Phase of the Project, including a cost 42 escalation approved by the County Administrator; and 43 44 WHEREAS, Staff recommends that the Mayor and City Commission find it in 45 the public interest to authorize entering into the Hall-005 Bus Shelter Improvements 46 Project Construction Phase Interlocal Agreement with Broward County for a total 47 amount of Three Million, One Hundred, Thirty Thousand, Four Hundred and Fifty-48 Three Dollars and Fifty-Four Cents (\$3,130,163.54), and authorize the City Manager 49 50 to execute relating documents. 51 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY 52 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA: 53 54 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein. 55 56 SECTION 2.
