12 **WHEREAS**, on September 26, 2024, the City Commission adopted the FY 2024-25
13 TISND Budget in the amount of \$575,226; and

15 **WHEREAS**, an additional appropriation of one million one- hundred thousand
16 (\$1,100,000) from the Three Islands Safe Neighborhood District fund balance is needed for
17 the three islands project improvements to the guardhouses and to vehicle traffic and
18 pedestrian safety in the Three Islands Safe Neighborhood District (TISND).

20 **WHEREAS**, this proposed amendment shall be submitted for approval by the City
21 Commission of the City of Hallandale Beach in accordance with the provisions of Florida
22 Statutes Sec. 163.5151 and, if tentatively approved, shall be subject to final approval by the
23 City Commission of the City of Hallandale Beach, in accordance with Sec. 200.065 with
24 respect to dependent special taxing districts; and

26 **WHEREAS**, the proposed tentative amendment has been publicly advertised in
27 accordance with the requirements of state statute.

36 Resolution by reference, is hereby amended as set forth in Attachment A.
