19 20	AND PROVIDING FOR AN EFFECTIVE DATE.

22	WHEREAS, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all
23	purchases of and contracts for equipment, supplies and contractual services, when the
24	estimated cost exceeds \$50,000, shall be based on competitive bids, and pursuant to Chapter
25	23, Section 23-6, Award of Contract, the City Manager shall have the authority to recommend
26	to the City Commission award of contracts; and
27	
28	WHEREAS, pursuant to Code of Ordinances, Chapter 23, Section 23-12, Procedures for
29	purchases in excess of \$50,000, (7) Change Orders, Any change in the contract price, scope
30	of work or time for completion of any project following the award of a contract shall be by a
31	written change order, approved by the city manager and executed with the same formalities
32	as the contract, and the scope of any project may be changed with prior approval of the city
33	commission; and

35	WHEREAS, Bid # FY 2021-2022-011 Historic Village and Curci House Improvements was
36	competitively bid and released on May 16, 2022 and the City Commission approved, through
37	Resolution 2022-088, an award contract to Campus Construction Group, Inc. on September 12,
38	2022; and

WHEREAS, on September 28, 2022, the City Commission of the City of Hallandale Beach
authorized Resolution No. 2022-088 awarding Bid RFP# FY2021- 2022-011, Historic Village
and Curci House Improvements, to Campus Construction Group, Inc. in the following
amounts for Campus Construction Group, Inc.in the amount of \$462,777.00, plus a Project
Contingency of (15%), \$69,417.00; and

WHEREAS, Change Orders #1 and #2 were administratively approved pursuant to City
 Procurement policies for a total amount of Fifty-Nine Thousand, Eight Dollars (\$59,008); and

50 WHEREAS, the groundwork has been completed and the only pending item is the installation 51 of the ADA Lift for the Curci House, which has already been fabricated and is ready for installation; 52 and

54 WHEREAS, during demolition of the ADA Lift door openings at the first and second floors of 55 the Curci House, it was discovered that the existing steel reinforcement was not as shown in the 56 structural plans and a sub consultant to ACAI Associates, Inc. was contracted directly by the City 57 to update and revise the plans accordingly, since ACAI Associates, Inc. closed their business in 58 March of 2024; and

60 **WHEREAS**, at this time, additional columns, beam and shoring of window lintels are 61 necessary to support the ADA Lift lateral forces; and

62

63 WHEREAS, Staff recommends that the Mayor and City Commission find it in the public 64 interest to authorize Change Order #3 for the RFP# FY2021-2022-011, Historic Village and 65 Curci House Improvements contract with Campus Construction Group, Inc., to authorize the 66 additional cost of seventy four thousand six hundred and thirty-seven (\$74,637) dollars for the 67 ADA Lift structural support, which exceeds the available remaining contingency, as approved via 68 Resolution No. 2022-88.

Change Order #3 for the RFP# FY2021-2022-011, Historic Village and Curci House 77 Improvements contract with Campus Construction Group, Inc., for seventy four thousand six 78 79 hundred and thirty-seven (\$74,637) dollars for the ADA Lift structural support, and increase 80 the construction funding (contract award total) in the amount of Sixty-Four Thousand, Two 81 Hundred and Twenty Eight Dollars (\$64,228), bringing the revised total contract to a not to exceed amount of to Five Hundred, Ninety=Six Thousand, Four Hundred and Twenty-Two Dollars 82 83 (\$596,422), authorize an extension of the time to complete the project through September 30, 84 2025, and authorize the City Manager to execute all relating documents. 85 SECTION 3.
