6 AUTHORIZING THE CITY MANAGER TO REJECT ALL  
7 RESPONSES TO RFP # FY 2022-2023-009 FOR ROADWAY  
8 RESTORATION AND REPAIR DUE TO FAILED  
9 NEGOTIATIONS WITH AWARDED VENDOR AND  
10 READVERTISE; REPEALING RESOLUTION 2023-065; AND  
11 PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, pursuant to Chapter 23, Section 23-4, City of Hallandale Beach Code of  
15 Ordinances, purchases of and contracts for equipment, supplies and contractual services,  
16 when the estimated cost shall exceed \$50,000.00, except as specifically provided in that  
17 section, shall be based, wherever possible, on competitive bids Code of Ordinances, Code  
18 of Ordinances, Code of Ordinances; and  
19

20 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Chapter  
21 23, Section 23-12, Procedures for purchases in excess of \$50,000, (4) Rejection of Bids, the  
22 City Commission may authorize City Manager to: a) Reject all bids; or b) reject all bids and  
23 re-advertise; and

25 **WHEREAS**, on June 21,2023, the City Commission adopted Resolution 2023-065  
26 authorizing the City Manager to negotiate an agreement with Weekley Asphalt Paving, Inc.  
27 in response to RFP No. FY 2022-2023-09; and

29 **WHEREAS**, the City and the vendor were unable to negotiate an agreement, and the  
30 Vendor became unresponsive to further negotiations; and

32 **WHEREAS**, Staff recommends that the Mayor and City Commission find it in the public  
33 interest to, and authorize the City Manager to, reject all bids for RFP No. FY 2022-2023-009  
34 – Roadway Restoration and Repair and readvertise, and authorize the City Manager to sign  
35 all related documents.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1.** The foregoing “Whereas” clauses are incorporated herein.

**SECTION 2.** The Mayor and City Commission hereby repeal Resolution 2023-065, reject all bids for RFP No. FY 2022-2023-009 – Roadway Restoration and Repair and readvertise, and authorize the City Manager readvertise as necessary.

**SECTION 3.** This Resolution shall take effect immediately upon its passage and adoption.
