Since 1999, I am an owner at Oceanview Park Condo, unit 202 at 800 Parkview Drive in Hallandale Beach. I have been paying corresponding annual property taxes and now I am completely outraged by this special assessment.

A special assessment to make our <u>streets and park safer</u> in addition to working on the roads? ... adding trees and bike paths? Where in our park is there room for a bike path besides the walking path (which is used by the "<u>public</u>" not just residents of Three Islands.

If the park should be safer for the children, take it up with the engineers from Parks and Recreation who designed and built it; it's their responsibility. It is only the officials who feel this is warranted, not the residents who live here. Putting a special assessment on private communities for road and park improvements which we have been allocated for in our taxes is unwarranted and criminal.

Further, the city's neglect of the roads seems a violation of the duty of officials and the <u>DOT</u>, not the residences who pay their annual taxes. Regarding the road construction on Atlantic Shores for the past year – were the property owners assessed for that??

And why now? This condo community is up against our own special assessment for \$millions replacing the roofs, etc. for "safety and code requirements" and the idea of adding another assessment on top of this which is <u>not detrimental</u> to our "safety" should be off the table. The residents here, many of whom are retirees without extra income, are concerned about how they are going to finance their own building assessment and not find themselves in foreclosure. The concept of adding unequal taxation to one group of residents in one arbitrary unrestricted area of a community is more than questionable and crosses the line.

Were the owner/residents living by Atlantic Shores (who uses the park and streets on Three Islands) assessed for the road work this past year on Atlantic Shores? Maintain the area in the exact manor as any other road in the city offering full public access to any and all traffic. It is not a distinct area.

Focus on what is truly needed. We, the residents, have never heard one complaint. In fact, our traffic flow is easy and a pleasure to come home to even when being used by non-residents visiting Wal-Mart.

Further, the gatehouse has been unoccupied for many years and contributes zero value to the road other than to slow traffic entering and exiting as a speed bump. Allocating dollars to improve a useless vacant gatehouse lacks any critical thinking or responsible allocation of revenue. Three islands is NOT A GATED COMMUNITY.

I request that city officials propose ONLY fair and equitable treatment of all taxpayers of Hallandale Beach.

## To the Administration of Hallandale Beach.

I am writing to express my deep concern and formal objection regarding the recently imposed special assessment levied on all residents for city infrastructure improvements. I hereby wish to officially appeal this decision.

Firstly, as homeowners, we already contribute substantial amounts in property taxes, which are intended to fund such municipal projects. Secondly, these significant expenses should be incorporated into the city's budget at the governmental level, rather than being extracted from ordinary citizens who are already burdened with exorbitant Homeowners Association (HOA) fees and substantial special assessments within our residential complexes.

Many of us are struggling to meet our existing financial obligations. In the aftermath of the COVID-19 pandemic, the cost of living has risen sharply, while our incomes have remained stagnant. The city must consider the number of residents who may face financial ruin or be pushed to the brink of bankruptcy due to these additional charges.

To illustrate, my monthly financial obligations for fully paid-off properties are as follows:

- HOA Fees: \$649 (Apartment 1) + \$858 (Apartment 2) / per month
- Special Assessments: \$211 (Apartment 1) + \$215 (Apartment 2) / per month
- **Property Taxes:** \$170 (Apartment 1) + \$500 (Apartment 2) / per month

**Total Monthly Payments:** \$2,603 (Considering that I have no mortgage and the apartments are fully paid off, I can't even imagine what the total amount would be if there were a mortgage on them)

This does not even take into account the costs of various insurances, groceries, and other regular expenses that accumulate to a substantial monthly total.

After being laid off from my government position in television due to unexplained downsizing, I am now self-employed, earning approximately \$3,500 to \$5,000 per month. With such financial constraints, how am I expected to sustain a living, let alone consider starting a family under these conditions? The imposition of these unreasonable taxes is untenable.

Governor DeSantis has previously indicated intentions to eliminate annual property taxes. It would be more beneficial for the city to support and advance such initiatives.

The proposal for improvements have both items we need and don't need:

- The better taller or brighter lighting on the streets
- We need the streets restriped to clearly indicate parking places and center lines (we have been calling and complaining to the City for several years with no response).
- We need high speed cameras at the entrances, similar to the Turnpike, to capture license plates. Therefore, no need for gates.
- We do need continued monitoring of parking places in the community streets, speeding at the park, speeding above 25 mph on the local streets, and red light running at the intersections
- More frequent placement of portable speed limit warnings on the residential streets. These are more important than duck crossing permanent signs.

## We DON'T NEED:
