WHEREAS, Staff recommends that the Mayor and City Commission find it to be in the public interest to utilize the Section 23-8 (5) Unique Circumstances exception to the competitive bidding requirement in the Code of Ordinances to authorize a one-year agreement whereby Florida International University (FIU) will provide to the City, on an as needed basis, traffic and transportation services in a not to exceed amount of One Hundred Thousand Dollars (\$100,000) per year, up to a not to exceed amount of Three Hundred Thousand Dollars (\$300,000) if renewed by City, and to authorize the City Manager to execute relating documents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

The Mayor and City Commission hereby finds Unique Circumstances to waive competitive bidding and authorize a one-year agreement with Florida International University (FIU) to provide to the City, on an as needed basis, traffic and transportation services in a not to exceed amount of One Hundred Thousand Dollars (\$100,000) per year, up to a not to exceed amount of Three Hundred Thousand Dollars (\$300,000) if renewed by City, and to authorize the City Manager to negotiate and execute relating documents.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
