4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,
6 AUTHORIZING CONTRACT WITH BIG TRUCK RENTAL, LLC
7 FOR EQUIPMENT RENTALS AND RELATED PRODUCTS
8 AND SERVICES FOR FISCAL YEAR 2025-2026 IN AN
9 AMOUNT NOT-TO-EXCEED SEVEN HUNDRED SEVENTY-
10 SEVEN THOUSAND, FOUR HUNDRED DOLLARS (\$777,400)
11 TO CONTINUE RENTING SIX FRONT LOAD TRUCKS; AND
12 PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, pursuant to Section 23-5 (a) of the City of Hallandale Beach Code of
15 Ordinances, Subsection (3), the City may utilize a contract or arrangement whereby two or
16 more public entities have the opportunity to purchase from the same supplier or multiple
17 suppliers using a single competitive procurement mechanism, and Subsection (4), the City
18 may procure goods or services from vendors who have been selected as a result of a
19 competitive selection process by another governmental entity, so long as the selection
20 process utilized by the contracting entity is substantially similar to the requirements of the
21 City and the goods or services procured by the City are procured pursuant to the original
22 contract scope and terms; and

24 **WHEREAS**, the City of Hallandale Beach's Sanitation Division's commercial, multi-
25 family, and residential solid waste collection services operate seven days a week all year
26 long; and

28 **WHEREAS**, the Division has made great strides in the last three years updating the
29 fleet with a hybrid mix of owned and leased rental vehicles, and currently rents six front load
30 trucks pursuant to the competitively solicited OMNIA PARTNERS contract #2019000319 with
31 Big Truck Rental, LLC for Equipment Rentals and Related Products and Services; and

33 **WHEREAS**, Staff recommends that the Mayor and City Commission find it to be in the
34 public interest to authorize utilization of the competitively solicited OMNIA PARTNERS
35 cooperative contract #2019000319 with Big Truck Rental, LLC for Equipment Rentals and
36 Related Products and Services for fiscal year 2025-2026 in an amount not-to-exceed Seven

37 Hundred Seventy-Seven Thousand, Four Hundred Dollars (\$777,400) to continue renting six
38 front load trucks, and authorize the City Manager to execute relating documents.

40 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
41 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

43 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

45 **SECTION 2.** The Mayor and City Commission hereby authorize utilization of the
46 competitively solicited OMNIA PARTNERS cooperative contract #2019000319 with Big Truck
47 Rental, LLC for Equipment Rentals and Related Products and Services for fiscal year 2025-
48 2026 in an amount not-to-exceed Seven Hundred Seventy-Seven Thousand, Four Hundred
49 Dollars (\$777,400) to continue renting six front load trucks, and authorize the City Manager
50 to execute relating documents.

52 **SECTION 3.** This Resolution shall take effect immediately upon its passage and
53 adoption.
