WHEREAS, the City of Hallandale Beach's Sanitation Division's commercial, multifamily, and residential solid waste collection services operate seven days a week all year long; and

WHEREAS, the Division has made great strides in the last three years updating the fleet with a hybrid mix of owned and leased rental vehicles, and currently rents six front load trucks pursuant to the competitively solicited OMNIA PARTNERS contract #2019000319 with Big Truck Rental, LLC for Equipment Rentals and Related Products and Services; and
