8 BID # FY 2024-2025-27 THREE ISLANDS GUARD HOUSE AND
9 TRAFFIC CALMING PROJECT (CIP2608) CONSTRUCTION
10 CONTRACT IN AN AMOUNT OF FOUR MILLION, EIGHT
11 HUNDRED, FORTY-TWO THOUSAND, TWO HUNDRED AND
12 SEVENTY-FOUR DOLLARS (\$4,842,274); AND AUTHORIZE A
13 10% CONTINGENCY, FOR A TOTAL NOT TO EXCEED COST
14 OF FIVE MILLION, THREE HUNDRED, TWENTY-SIX
15 THOUSAND, FIVE HUNDRED AND TWO DOLLARS
16 (\$5,326,502); AND PROVIDING FOR AN EFFECTIVE DATE.

19 **WHEREAS**, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all
20 purchases of and contracts for equipment, supplies, and contractual services, when the estimated
21 cost shall exceed \$50,000, shall be based on competitive bids and pursuant to Chapter 23,
22 Section 23-6, Award of Contract, the City Manager shall have the authority to recommend to the
23 City Commission award of contracts; and

25 **WHEREAS**, on July 8, 2025, the City of Hallandale Beach released Bid # FY 2024-2025-
26 27 THREE ISLANDS GUARD HOUSE AND TRAFFIC CALMING PROJECT (CIP2608) to
27 enhance safety, accessibility, and overall quality of life within the Three Islands neighborhood
28 through a coordinated set of infrastructure and aesthetic improvements including traffic calming
29 measures, ADA-compliant ramps and clearly marked crosswalks to ensure safe and inclusive
30 mobility, upgraded landscaping and lighting around guardhouses to improve both visibility and
31 curb appeal electronic speed feedback signs to promote safe driving, dedicated bike lane
32 markings to encourage alternative transportation, and upgrades to guardhouses through
33 repainting and the replacement of gate arms to maintain secure, well-presented entry points along
34 Three Islands Boulevard, Atlantic Shores Boulevard, Parkview Drive, and Leslie Drive; and

36 **WHEREAS**, according to Staff, the Estimate of Probable Cost for the Bid # FY 2024-2025-
37 27 THREE ISLANDS GUARD HOUSE AND TRAFFIC CALMING PROJECT (CIP2608) project

was Four Million, Five Hundred Thousand Dollars (\$4,500,000); two bids were received but only the lowest priced bid was responsive due to irregularities in unit pricing; and

WHEREAS, Staff recommends that the Mayor and City Commission find it to be in the public interest to award to JVA Engineering Contractor, Inc., as the lowest and sole responsive bidder, the Bid # FY 2024-2025-27 THREE ISLANDS GUARD HOUSE AND TRAFFIC CALMING PROJECT (CIP2608) construction contract in an amount of Four Million, Eight Hundred, Forty-Two Thousand, Two Hundred and Seventy-Four Dollars (\$4,842,274) and authorize a 10% contingency for a total not to exceed cost of Five Million, Three Hundred, Twenty-Six Thousand, Five Hundred and Two Dollars (\$5,326,502), and authorize the City Manager to execute relating documents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. Whereas Clauses. The foregoing "Whereas" clauses are incorporated herein.

SECTION 2. Authorization. The Mayor and City Commission hereby award to JVA Engineering Contractor, Inc., as the sole responsive bidder, the Bid # FY 2024-2025-27 THREE ISLANDS GUARD HOUSE AND TRAFFIC CALMING PROJECT (CIP2608) construction contract in an amount of Four Million, Eight Hundred, Forty-Two Thousand, Two Hundred and Seventy-Four Dollars (\$4,842,274) and authorize a 10% contingency for a total not to exceed cost of Five Million, Three Hundred, Twenty-Six Thousand, Five Hundred and Two Dollars (\$5,326,502), and authorize the City Manager to execute relating documents.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
