4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,
6 APPROVING THE INTERLOCAL AGREEMENT BETWEEN
7 THE CITY OF HALLANDALE BEACH AND THE
8 HALLANDALE BEACH COMMUNITY REDEVELOPMENT
9 AGENCY RELATING TO THE PROVISION OF DIRECT
10 SERVICES IN THE FORM OF ADDITIONAL CODE
11 COMPLIANCE SERVICES FOR FISCAL YEAR 2025-2026;
12 AND PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, the Hallandale Beach Community Redevelopment Agency (HBCRA)
15 desires to enter into an agreement with the City of Hallandale Beach (“City”) to enhance Code
16 Compliance Services to promote greater voluntary compliance of code violations in the CRA;
17 and

18 **WHEREAS**, the HBCRA agrees to pay for an additional code compliance specialist to
19 respond to complaints of possible code violations in a timely and effective manner in order to
20 maintain a higher quality standard of living within the CRA; and

21 **WHEREAS**, Staff recommends that the Mayor and City Commission approve an
22 Interlocal Agreement between the HBCRA and the City for direct costs relating to additional
23 Code Compliance Services for Fiscal Year 2025-2026 in an amount not to exceed Ninety
24 Three Thousand Six Hundred and Forty-Two 00/100 Dollars (\$93,642.00).

25 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
26 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

28 **SECTION 1. Recitals.** The foregoing “Whereas” clauses are hereby adopted
29 herein.

31 **SECTION 2. Approval of Interlocal Agreement.** The Mayor and City Commission
32 hereby approve an Interlocal Agreement between the HBCRA and the City for direct costs
33 relating to additional Code Compliance Services for Fiscal Year 2025-2026 in an amount not
34 to exceed Ninety Three Thousand Six Hundred and Forty-Two 00/100 Dollars (\$93,642.00).

36 **SECTION 3. Execution of Interlocal Agreement.** The City Manager is hereby
37 authorized to execute the Interlocal Agreement attached as Exhibit "A" hereto and to take all
38 steps necessary and appropriate to implement the terms and conditions of the Interlocal
39 Agreement.

40 **SECTION 4. Effective Date.** This Resolution shall take effect immediately upon its
41 passage and adoption.
