SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING UTILIZATION OF THE OMNIA PARTNERS CONTRACT WITH PLAYCORE WISCONSIN INC, DBA GAMETIME TO PURCHASE REPLACEMENT OF PLAYGROUND EQUIPMENT AND PLAYGROUND SURFACING AT THE DR. MARTIN LUTHER KING, JR. PARK FOR A TOTAL NOT TO EXCEED AMOUNT OF THREE HUNDRED, EIGHTY-TWO THOUSAND, EIGHT HUNDRED, TWENTY-NINE DOLLARS AND NINETY-ONE CENTS (\$382,829.91); AND PROVIDING FOR AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

The purpose of the agenda item is to request the City Commission approve the attached resolution authorizing the City Manager to procure playground equipment and playground surfacing from Playcore Wisconsin Inc, dba GameTime utilizing OMNIA Partners Contract 2017001134 for a total amount not to exceed \$382,829.91.

Background:

As part of the FY2025 budget process, park amenities were inspected for replacement and placed onto the Renewal and Replacement list. The playground at Dr. MLK, Jr Park was identified for replacement.

Parks staff worked to source vendors for the project and selected Playcore Wisconsin Inc, dba GameTime.

Current Situation:

The playground at Dr. MLK, Jr Park is in need of replacement due to rusting and deteriorating of the equipment. Staff would like to move forward with replacement at this time

Staff seeks to piggyback the agreement between OMNIA Partners and Playcore Wisconsin Inc, dba GameTime via contract number 2017001134. Under this agreement, staff will utilize funds in the amount of \$382,829.91 currently budgeted for FY 2025-2026.

The initial term of the OMNIA Partners KOMPAN Inc contract was from July 1, 2017 through June 30, 2022. On April 19, 2022, the first renewal period was exercised and provided a new expiration date of June 30, 2024. On May 30, 2023, the second and final renewal period was exercised and provides a new expiration date of June 30, 2026.

OMNIA Partners was established with the purpose of assisting public agencies in meeting specific needs which are more efficiently delivered cooperatively than by an entity individually. OMNIA Partners is authorized to establish competitively awarded cooperative purchasing contracts on behalf of itself and its participating agencies. OMNIA Partners clients are able to utilize cooperative purchasing contracts in their respective jurisdiction. Participating agencies include all eligible government and education agencies. The services to be provided by Playcore Wisconsin Inc, dba GameTime include the removal of the current playground and replacement with custom GameTime playground pieces to include safety surfacing.

Why Action is Necessary:

Pursuant to Code of Ordinances, in accordance with Procurement Code Section 23-5 Competitive procurement required; Procurement Mechanisms, (3) Cooperative Purchasing. Includes a variety of arrangements whereby two or more public entities have the opportunity to purchase from the same supplier or multiple suppliers using a single competitive procurement mechanism. Furthermore, Section 23-9, Award, (e) The City Manager may award procurements within the delegated spending authority. All other procurements, except emergency procurements, require commission approval for award.

Cost Benefit:

Utilization of this contract will provide cost savings due to economies of scale. By utilizing this contract, the City can purchase the goods and services through a cooperative procurement process where all equipment, products or services are priced at or below the supplier's proposal.
