RESOLUTION NO. 2026 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION
OF THE CITY OF HALLANDALE BEACH, FLORIDA,
AUTHORIZING UTILIZATION OF SOURCEWELL MASTER
AGREEMENT TO PURCHASE A REPLACEMENT GRAPPLE
TRUCK, BODY AND APPROPRIATE ACCESSORIES FROM
RDK TRUCK SALES AND SERVICE, INC. FOR A NOT TO
EXCEED PURCHASE PRICE OF TWO HUNDRED, NINE
THOUSAND AND NINE HUNDRED DOLLARS (\$209,900); AND
PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to the City of Hallandale Beach Code of Ordinances, Section

23-9, Award, (e), the City Manager may award procurements within the delegated spending authority, and all other procurements, except emergency procurements, require commission approval for award; and

WHEREAS, pursuant to the City of Hallandale Beach Code of Ordinances, Section

23-5 Competitive procurement required; Procurement Mechanisms, Subsection (3) Cooperative Purchasing, the City may procure goods or services through a variety of arrangements whereby two or more public entities have the opportunity to purchase from the same supplier or multiple suppliers using a single competitive procurement mechanism, and Subsection (4) Piggybacking, the City may procure goods or services from vendors who have been selected as a result of a competitive selection process by another governmental entity if the selection process utilized by the contracting entity was substantially similar to the requirements of the City, and the goods or services procured by the City are procured pursuant to the original contract scope and terms; and

WHEREAS, the City of Hallandale Beach currently owns three (3) large grapple refuse that are used to remove bulk refuse materials, which is an essential service because provides a safe, clean, and efficient way to dispose of large items that cannot be handled through regular trash service, without which more bulky waste would likely be dumped illegally, posing health risks, safety hazards, and neighborhood blight; and

37 **WHEREAS**, the oldest of these grapple refuse trucks, Unit 999, is a 2010 Freightliner
38 grapple truck that has reached the end of its operational lifecycle, and replacing it is
39 necessary to prevent service interruptions and ensure an appropriate and reliable level of
40 service for residents; and

42 **WHEREAS**, City received a quote from RDK Truck Sales and Service, Inc. for a
43 replacement grapple truck, body and appropriate accessories utilizing a Sourcewell Master
44 Agreement #010825 for a not to exceed purchase price of Two Hundred, Nine Thousand and
45 Nine Hundred Dollars (\$209,900); and

47 **WHEREAS**, Staff recommends that the Mayor and City Commission authorize
48 utilization of Sourcewell Master Agreement #010825 to purchase a replacement grapple
49 truck, body and appropriate accessories from RDK Truck Sales and Service, Inc. for a not to
50 exceed purchase price of Two Hundred, Nine Thousand and Nine Hundred Dollars
51 (\$209,900) and authorize the City Manager to execute related documents to effectuate the
52 purchase.

54 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
55 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

57 **SECTION 1. Whereas Clauses.** The foregoing "Whereas" clauses are incorporated
58 herein.

60 **SECTION 2. Authorization.** The Mayor and City Commission hereby authorize
61 utilization of Sourcewell Master Agreement #010825 to purchase a replacement grapple
62 truck, body and appropriate accessories from RDK Truck Sales and Service, Inc. for a not to
63 exceed purchase price of Two Hundred, Nine Thousand and Nine Hundred Dollars
64 (\$209,900) and authorize the City Manager to execute related documents to effectuate the
65 purchase.
