RESOLUTION NO. 2026 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE FILING, ACCEPTANCE AND EXECUTION OF 52ND YEAR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) APPLICATIONS FOR FY 2026-27 FOR AFTERSCHOOL TUTORIAL PROGRAM IN THE AMOUNT OF NINETY-FOUR THOUSAND DOLLARS (\$94,000) TO SERVE A MINIMUM OF 166 LOW TO MODERATE INCOME STUDENTS AND DRAINAGE, SIDEWALKS, REGRADING AND SODDING OF SWALES AND OTHER RELATED INFRASTRUCTURE IMPROVEMENTS ALONG NW 1ST STREET BETWEEN NW 8TH AVENUE AND NW 7TH AVENUE IN THE AMOUNT OF FOUR HUNDRED AND FIFTY THOUSAND DOLLARS (\$450,000); AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Article V, Section 5.01, of the City of Hallandale Beach Charter, Resolutions are to be presented to and adopted by a majority of the Commission, and pursuant to Broward County and the Community Development Block Grant (CDBG) program guidelines, a resolution of the City Commission authorizing the grant application is required; and

WHEREAS, Staff recommends filing CDBG grant applications for FY 2026-27 1) Afterschool Tutorial Program in the amount of Ninety-Four Thousand Dollars (\$94,000) to serve a minimum of 166 low to moderate income students and 2) drainage, sidewalks, regrading and sodding of swales and other related infrastructure improvements along NW 1st Street between NW 8th Avenue and NW 7th Avenue in the amount of Four Hundred and Fifty Thousand Dollars (\$450,000); and

WHEREAS, Staff recommends that the Mayor and City Commission authorize filing of 52nd Year Community Development Block Grant applications for 1) Afterschool Tutorial Program in the amount of Ninety-Four Thousand Dollars (\$94,000) to serve a minimum of 166 low to moderate income students and 2) drainage, sidewalks, regrading and sodding of swales and other related infrastructure improvements along NW 1st Street between

51 applications for FY 2026-27 for 1) afterschool tutorial program in the amount of Ninety-Four
52 Thousand Dollars (\$94,000) to serve a minimum of 166 low to moderate income students and
53 2) drainage, sidewalks, regrading and sodding of swales and other related infrastructure
54 improvements along NW 1st Street between NW 8th Avenue and NW 7th Avenue in the
55 amount of Four Hundred and Fifty Thousand Dollars (\$450,000), and authorize the City
56 Manager to execute relating documents.

58 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
59 passage and adoption.
