19	administrative and petition costs, and to exclude certain liens from being eligible for lien

21	WHEREAS, Staff has researched the best practice model for governing the mitigation		
22	of fines and lien process and recommends; and		
23	WHEREAS, the increase in compliance requirements and the clearing of multiple liens		
24	from the same applicant should improve property values which is in the interest of the City of		
25	Hallandale Beach, and Staff recommends that the Mayor and City Commission approve of		
26	the Amended Mitigation Policy set forth in attached Exhibit A.
