RESOLUTION NO. 2026-

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF HALLANDALE BEACH, FLORIDA, AUTHORIZING SETTLEMENT PAYMENT TO REYNALDO MAYOR AND LINDA PANZARELLA FOR PERSONAL INJURIES RESULTING FROM A MOTOR VEHICLE ACCIDENT IN EXCHANGE FOR A RELEASE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Claimant was involved in a vehicle collision with a City vehicle; and

WHEREAS, a lawsuit was filed for bodily injury and Claimant has agreed to settle the bodily injury claim in the amount of Fifty Thousand (\$50,000.00) Dollars; and

WHEREAS, staff recommends settlement of the for the bodily injury claim; and

WHEREAS, pursuant to Chapter 24, Section 24-3(d) of the City of Hallandale Beach, Code of Ordinances, proposed settlements in excess of \$20,000.00 total per incident shall be submitted to the City Commission for its decision; and

WHEREAS, the Mayor and City Commission, being fully advised of the facts of this matter, believe it is in the best interest of the City to resolve the bodily injury portion of this claim.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing “Whereas” clauses are confirmed as true and incorporated herein.

SECTION 2. Approve Settlement. The Mayor and City Commission hereby authorize settlement of Fifty Thousand Dollars (\$50,000) for the bodily injury claim of

37 liability; and further authorize the City Manager and City Attorney to execute any and all
38 necessary documents to effectuate settlement of the case.
