RESOLUTION NO. 2025 - 079

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA AUTHORIZING EXECUTION OF THE INTERLOCAL AGREEMENT (ILA) BETWEEN THE CITY OF HALLANDALE BEACH AND BROWARD COUNTY TO PROVIDE SURTAX FUNDING TO THE CITY FOR THE CITY HALL-004 SIDEWALK ADA IMPROVEMENTS PROJECT, CONSTRUCTION PHASE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in order to receive surtax funding for the City Hall-004 Sidewalk ADA Improvements (BC-HBEACH-FY2020-00001) Project, Construction Phase, the City Commission must approve a proposed ILA via Resolution; and

WHEREAS, the City Hall-004 Sidewalk ADA Improvements Project is included in the City's 5-Year Capital Improvement Plan (CIP) and the project was submitted to MAP Broward for surtax funding; and

WHEREAS, City Hall-004 Sidewalk ADA Improvements (BC-HBEACH-FY2020-00001) Project, Construction Phase, was determined to be statutorily eligible for funding and subsequent approval for funding by the Broward County Board of County Commissioners; and

WHEREAS, Staff recommends that the Mayor and City Commission find it to be in the public interest to authorize execution of the Interlocal Agreement (ILA) between the City and Broward County to provide Surtax funding to the City for the City Hall-004 Sidewalk ADA Improvements (BC-HBEACH-FY2020-00001) Project, Construction Phase, which will grant the City Two Million, Seven Hundred, Thirteen Thousand, Five Hundred, Fifty-Nine Dollars and Six Cents (\$2,713,559.06) towards the Construction Phase of the project, and authorize the City Manager to execute relating documents.
