4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,
6 AUTHORIZING UTILIZATION OF THE COOPERATIVE
7 AGREEMENT BETWEEN SOURCEWELL AND 72 HOUR LLC
8 D/B/A NATIONAL AUTO FLEET GROUP TO PURCHASE
9 EIGHT (8) REPLACEMENT POLICE VEHICLES IN AN
10 AMOUNT NOT TO EXCEED FOUR HUNDRED, NINETY-NINE
11 THOUSAND, SIX HUNDRED AND SIXTEEN DOLLARS
12 (\$499,616); AND PROVIDING FOR AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances Section
16 23-5, the City may procure goods or services from vendors who have been selected as a
17 result of a competitive selection process by another entity if the selection process utilized by
18 the contracting entity was substantially similar to the requirements of the City, and the
19 goods or services procured by the City are procured pursuant to the original contract scope
20 and terms; and

22 **WHEREAS**, the City of Hallandale Beach Fleet Department has implemented a
23 vehicle replacement plan that balances the cost of ownership with the operability of fleet
24 assets, taking into account factors such as age, utilization, and anticipated surplus value on
25 the secondary market, and requests replacement of eight vehicles at the end of their lifecycle
26 for FY2025-26; and

28 **WHEREAS**, Staff recommends that the Mayor and City Commission find it in the public
29 interest to authorize utilization of the cooperative agreement between Sourcewell and 72 Hour
30 LLC d/b/a National Auto Fleet Group (Cars, trucks, vans, SUVs, cab chassis, and other
31 vehicles) No.: 091521-NAF 091521-NAF to purchase eight (8) replacement police vehicles at
32 the end of their lifecycle from Alan Jay Automotive Management Inc. at discounted rates for
33 FY 2025-26 in an amount not to exceed Four Hundred, Ninety-Nine Thousand, Six Hundred
34 and Sixteen Dollars (\$499,616) and to authorize the City Manager to execute related
35 documents to effectuate the purchase.

44 **SECTION 2. Authorization.** The Mayor and City Commission hereby authorize
45 utilization of the cooperative agreement between Sourcewell and 72 Hour LLC d/b/a National
46 Auto Fleet Group (Cars, trucks, vans, SUVs, cab chassis, and other vehicles) No.: 091521-
47 NAF 091521-NAF to purchase eight (8) replacement police vehicles at the end of their
48 lifecycle from Alan Jay Automotive Management Inc. at discounted rates for FY 2025-26 in
49 an amount not to exceed Four Hundred, Ninety-Nine Thousand, Six Hundred and Sixteen
50 Dollars (\$499,616) and authorize the City Manager to execute related documents to
51 effectuate the purchase.
