21	vehicles, two rentals and four City-owned automated residential refuse sideloader trucks; and

23	WHEREAS, Staff has confirmed that automated residential refuse Unit #1252, a 2017
24	model year sideloader truck, has reached the end of its operational lifecycle, and its
25	replacement is necessary to prevent service interruptions and to maintain an appropriate level
26	of service for residents; and
27	
28	WHEREAS, the City has located an opportunity to purchase a vehicle that another
29	organization had ordered but later decided not to purchase, resulting in a cost savings to the
30	City of Hallandale Beach over \$15,000, from vendor Environmental Products Group, Inc.
31	utilizing Sourcewell contract 110223-LEG in a not-to-exceed amount of Three Hundred,
32	Ninety Thousand Dollars (\$390,000); and

34	WHEREAS, Staff recommends that the Mayor and City Commission find it to be in the
35	public interest to replace end-of-life automated residential refuse Unit #1252 sideloader truck
36	from vendor Environmental Products Group, Inc. utilizing Sourcewell contract 110223-LEG
