23	approved by the City, and was modified during the initial contract term to add fees for						
24	pickleball, to increase the light fee, and to add an hourly fee for hard court use by members;

WHEREAS, Staff recommends that the Mayor and City Commission find it to be in the public interest to authorize entering into Amendment No. 2 to the Golden Isles Tennis Center Operating Agreement between the City of Hallandale Beach and All Florida Tennis, LLC (Operator) for the operation of the Golden Isles Tennis Center exercising the first renewal term for an additional period of five (5) years, and allowing Operator to retain earnings of hard court fees.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. Whereas Clauses. The foregoing "Whereas" clauses are incorporated herein.

SECTION 2. Authorization. The Mayor and City Commission hereby authorize entering into Amendment No. 2 to the Golden Isles Tennis Center Operating Agreement between the City of Hallandale Beach and All Florida Tennis, LLC for the operation of the Golden Isles Tennis Center, 1) exercising the initial renewal term for an additional period of five (5) years and 2) allowing Operator to retain 100% of gross earnings of hard court fees each year up to the \$300,000 cap, after which the City earns 4%, and authorize the City Manager to execute relating documents.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
