4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,
6 AUTHORIZING UTILIZATION OF FLORIDA SHERIFF
7 ASSOCIATION'S COOPERATIVE FSA CONTRACT TO
8 PURCHASE TIRES ON AN AS NEEDED BASIS FROM
9 AUTHORIZED DEALERS IN AN AMOUNT NOT TO EXCEED
10 ONE HUNDRED THOUSAND DOLLARS (\$100,000), FOR FY
11 2025-26; AND PROVIDING FOR AN EFFECTIVE DATE.

14 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section
15 23-9, Award, (e), the City Manager may award procurements within the delegated spending
16 authority, and all other procurements, except emergency procurements, require commission
17 approval for award; and

19 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section
20 23-5 Competitive procurement required; Procurement Mechanisms, Subsection (3)
21 Cooperative Purchasing, the City may procure goods or services through a variety of
22 arrangements whereby two or more public entities have the opportunity to purchase from
23 the same supplier or multiple suppliers using a single competitive procurement mechanism,
24 and Subsection (4) Piggybacking, the City may procure goods or services from vendors
25 who have been selected as a result of a competitive selection process by another
26 governmental entity if the selection process utilized by the contracting entity was
27 substantially similar to the requirements of the City, and the goods or services procured by
28 the City are procured pursuant to the original contract scope and terms; and

30 **WHEREAS**, the City of Hallandale Beach, Department of Public Works - Fleet
31 Maintenance Division, services and provides tire replacements for the Police, Code Compliance,
32 Parks and Recreation, Human Services and Public Works; and

34 **WHEREAS**, the City desires to utilize Florida Sheriff Association's FSA Contract No.
35 FSA25-TRS27.0-Tires to purchase tires on an as needed basis, from authorized dealers Earl W.
36 Colvard, Inc DBA Boulevard Tire and Conlan Tire CO LLC in an amount not to exceed One
37 Hundred Thousand Dollars (\$100,000), for FY 2025-26; and

39 **WHEREAS**, Staff recommends that the Mayor and City Commission authorize utilization
40 of Florida Sheriff Association's cooperative FSA Contract No. FSA25-TRS27.0-Tires to purchase
41 tires on an as needed basis, from authorized dealers Earl W. Colvard, Inc DBA Boulevard Tire
42 and Conlan Tire CO LLC in an amount not to exceed One Hundred Thousand Dollars (\$100,000),
43 for FY 2025-26 and authorize the City Manager to execute relating documents.

46 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

48 **SECTION 1. Whereas Clauses.** The foregoing "Whereas" clauses are incorporated
49 herein.

51 **SECTION 2. Authorization.** The Mayor and City Commission hereby authorize
52 utilization of Florida Sheriff Association's cooperative FSA Contract No. FSA25-TRS27.0-Tires to
53 purchase tires on an as needed basis, from authorized dealers Earl W. Colvard, Inc DBA
54 Boulevard Tire and Conlan Tire CO LLC in an amount not to exceed One Hundred Thousand
55 Dollars (\$100,000), for FY 2025-26 and authorize the City Manager to execute relating
56 documents.

58 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
59 passage and adoption.
