16	WHEREAS, issues have arisen with the meters which had led to impaired the		
17	City's ability to obtain accurate water usage readings; and		
18			
19	WHEREAS, following good faith negotiations, Sensus, the Distributor, Core		
20	and Main, and the City have agreed to resolve the dispute on the terms and conditions		
21	set forth in the Agreement attached hereto as Exhibit "A"; and		
22			
23	WHEREAS, as part of the settlement, City is agreeing to purchase five		
24	hundred fifty (550) 5/8" x 3/4" Replacement Meters at a price of one hundred five U.S.		
25	dollars (\$105.00) each and one thousand one hundred (1,100) 1" Replacement Meters		
26	at a price of one hundred thirty-two U.S. dollars and ninety-nine cents (\$132.99) each.		
27	The cost of the Replacement Meters includes the cost of installation, which shall be		
28	paid by Sensus and installed by Distributor utilizing VEPO Metering South, LLC; and		
29			
30	WHEREAS, Sensus will provide an additional one thousand five hundred		
31	(1500) 5/8" x 3/4" Replacement Meters at no charge to the City. The installation of		
32	these Replacement Meters will not be covered by Sensus or Distributor; and		
33			
34	WHEREAS, Staff recommends that the City Commission approve the		
35	proposed settlement agreement incorporated herein as Exhibit "A," to facilitate		

36	advancement of the project and authorize the City to proceed with the purchase as		
37	indicated therein pursuant to a finding of unique circumstances.
