4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,
6 AUTHORIZING THE PURCHASE THROUGH COOPERATIVE
7 SOURCEWELL AGREEMENT #031622 WITH
8 FOREVERLAWN, INC. OF K-9 CLASSIC GRASS AND
9 OTHER SERVICES AT THE CITY'S GOLDEN ISLES DOG
10 PARK IN THE AMOUNT NOT TO EXCEED ONE HUNDRED
11 TWENTY-THREE THOUSAND, FIVE HUNDRED, SEVENTY-
12 TWO DOLLARS (\$123,572); AND PROVIDING AN
13 EFFECTIVE DATE.

16 WHEREAS, pursuant to Section 23-9 of the City of Hallandale Beach ("City") Code,
17 the City Manager shall have the authority to join with other units of government in cooperative
18 purchasing plans or to purchase pursuant to formal written contracts or competitive bids of
19 other governmental units, when the best interests of the City would be served, subject to the
20 requirement that purchases in excess of \$50,000 require City Commission approval; and

22 WHEREAS, the Golden Isles Dog Park requires new sod, and Staff seeks to move
23 forward with the approved Capital Improvement Plan to replace the sod with artificial K9 grass
24 to improve the durability and user experience of the off-leash dog areas; and

26 WHEREAS, ForeverLawn, Inc. has contracted with cooperative Sourcewell
27 Agreement #031622, and has submitted a Cost Proposal to remove the current sod at the
28 dog park, replace it with K-9 Classic Grass using 100% plastic EPS nailer board perimeter,
29 4-inch compacted stone base for drainage, and provide all necessary pre installation
30 excavation in the amount not to exceed One Hundred Twenty-Three Thousand, Five
31 Hundred, Seventy-two Dollars (\$123,572); and

32 WHEREAS, Staff recommends that the Mayor and City Commission find that such
33 purchase is the public interest enabling savings due to economies of scale, and authorize the
34 purchase through cooperative Sourcewell Agreement #031622 with ForeverLawn, Inc. of K-
35 9 Classic Grass and other services at the City's Golden Isles Dog Park in the amount not to

36 exceed One Hundred Twenty-Three Thousand, Five Hundred, Seventy-Two Dollars
37 (\$123,572).

39 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
40 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

42 **SECTION 1.** The foregoing “Whereas” clauses are incorporated herein.

44 **SECTION 2.** The Mayor and City Commission hereby authorize the purchase
45 through cooperative Sourcewell Agreement #031622 with ForeverLawn, Inc. of K-9 Classic
46 Grass and other services at the City’s Golden Isles Dog Park in the amount not to exceed
47 One Hundred Twenty-Three Thousand, Five Hundred, Seventy-Two Dollars (\$123,572), and
48 authorize the City Manager to sign all related documents.

50 **SECTION 3.** This Resolution shall take effect immediately upon its passage and
51 adoption.
