**A RESOLUTION OF THE MAYOR AND CITY COMMISSION
OF THE CITY OF HALLANDALE BEACH, FLORIDA
SUPPORTING THE PEOPLE OF IRAN AND CONDEMNING
THE ISLAMIC REVOLUTIONARY GUARD CORPS; AND
PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the people of Iran continue to courageously seek freedom, human rights, and democratic reform; and

WHEREAS, women, religious minorities, journalists, and peaceful demonstrators in Iran have faced imprisonment, violence, and intimidation for exercising fundamental rights; and

WHEREAS, the Islamic Revolutionary Guard Corps (IRGC) has played a central role in violently suppressing peaceful protest, committing serious human rights abuses, and destabilizing the region; and

WHEREAS, the actions of the IRGC do not reflect the will of the Iranian people, but rather an apparatus of repression and intimidation; and

WHEREAS, the United States and Israel are longstanding allies committed to democratic values, human rights, and regional security, and both have recognized the IRGC as a destabilizing force that threatens peace and freedom.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing “Whereas” clauses are incorporated herein.

SECTION 2. The Mayor and City Commission hereby express their strong support for the people of Iran in their pursuit of liberty, dignity, and fundamental human rights; and condemn the actions of the Islamic Revolutionary Guard Corps (IRGC) for its role in human rights violations and repression. The City stands in solidarity with the United States, Israel,

36 and democratic allies in opposing tyranny, supporting accountability, and advocating for
37 peace and human rights in Iran and throughout the region.

39 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
