RESOLUTION NO. 2026 -**

**A RESOLUTION OF THE MAYOR AND CITY
COMMISSION OF THE CITY OF HALLANDALE
BEACH, FLORIDA AUTHORIZING AGREEMENT WITH
SECURITY ALLIANCE, LLC, FOR ARMED SECURITY
GUARD COVERAGE AT THE DPW COMPOUND AND
CITY HALL COMPLEX THROUGH FY 2030 FOR AN
AMOUNT NOT TO EXCEED ONE MILLION, SEVEN
HUNDRED THIRTY ONE THOUSAND, ONE HUNDRED
AND FORTY NINE DOLLARS (\$1,731,149); AND
PROVIDING AN EFFECTIVE DATE.**

15 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances,
16 Section 23-5 Competitive procurement required; procurement mechanisms,
17 Subsection (4) Piggybacking, the City may procure goods or services from vendors
18 who have been selected as a result of a competitive selection process by another
19 governmental entity if the selection process utilized by the contracting entity was
20 substantially similar to the requirements of the City, and the goods or services
21 procured by the City are procured pursuant to the original contract scope and terms;
22 and

24 **WHEREAS**, visible armed security guards are a strong deterrent against crime,
25 threats, vandalism and property damage, and having a presence to respond
26 immediately helps to potentially reduce casualties and damage and provides for a
27 safer environment for employees which improves employee morale and helps to
28 alleviate and minimize fear; and
29

30 **WHEREAS**, the City of Hallandale Beach adopted Resolution 2024-060 that
31 authorized utilization of an agreement between Security Alliance, LLC and Miami
32 Dade County to procure armed security guard services in the lobby of City Hall and at
33 the DPW Compound from Monday through Thursday, and metal detection services
34 during Commission Meetings for an amount of \$881,904 for a period of three (3) years,
35 ending August 31, 2026; and

37 **WHEREAS**, Staff asks to continue services by Security Alliance, LLC of armed
38 security guard coverage at the DPW compound, and at City Hall; and

40 **WHEREAS**, Staff recommends that the Mayor and City Commission find it to
41 be in the public interest to authorize the purchase from Security Alliance, LLC, as
42 competitively procured by Miami Dade County, to continue services at the current
43 service level of 24/7/365 armed security guard coverage at the DPW compound, and
44 at City Hall Complex for One Million, Seven Hundred Thirty One Thousand, and One
45 Hundred Forty Nine Dollars (\$1,731,149), for the period of September, 2026 through
46 August 31, 2030, subject to future appropriations, and authorize the City Manager to
47 execute relating documents.

49 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
50 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

52 **SECTION 1.** The foregoing “Whereas” clauses are incorporated herein.

53
54 **SECTION 2. City Manager Authorization.** The Mayor and City
55 Commission hereby authorize the purchase from Security Alliance, LLC, as
56 competitively procured by Miami Dade County, to continue services of 24/7/365 armed
57 security guard coverage at the DPW compound, and at City Hall Complex for One
58 Million, Seven Hundred Thirty One Thousand, and One Hundred Forty Nine Dollars
59 (\$1,731,149), for the period of September, 2026 through August 31, 2030, subject to
60 future appropriations, and authorize the City Manager to execute relating documents.

61 **SECTION 3. Effective Date.** This Resolution shall take effect
62 immediately upon its passage and adoption.
