14	WHEREAS, Section 163.3177(3) of the Florida Statutes and City of Hallandale			
15	Beach's Comprehensive Plan Capital Improvement Element requires a five-year			
16	schedule of Capital Improvements projects be maintained annually; and			
17				
18	WHEREAS, the intent of the Capital Improvements Program is to act as a guide			
19	to delineate the capital projects necessary to meet the overall needs of the City of			
20	Hallandale Beach; and			
21				
22	WHEREAS, the Capital Improvements Program is an effective planning tool for			
23	the City Commission, management staff, and the public in the evaluation of the City's			
24	future needs; and			
25				
26	WHEREAS, the adoption of the Capital Improvements Program is in keeping with			
27	the City's Comprehensive Plan, Policy 1.1.4 of the Capital Improvement Element, which			
28	states Capital Improvement needs for each individual element of the Comprehensive Plan			
29	must be aggregated and listed within the Capital Improvements Element; and

31	WHEREAS, Staff recommends that the City Commission approve this Ordinance			
32	adopting the 5-Year Capital Improvement Plan for fiscal year 2025 through 2029 on First			
33	Reading for September 12, 2024.

35	NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY			
36	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

38	SECTION 1. The Capital Improvements Program for Fiscal Year (FY) 2025			
39	through FY 2029, attached hereto as Exhibit "A" and made a part hereof, is hereby			
40	adopted.			
41	SECTION 2. That the first fiscal year (FY 2025) of the Capital Improvements			
42	Program is hereby approved as the capital budget of the City of Hallandale Beach in			
43	accordance with the Capital Improvements Element of the City's adopted Comprehensive			
44	Plan. Actual project authorization and appropriation are subject to approval in the FY			
45	2025 Budget.			
46	SECTION 3. The Capital Improvements Program identifies unfunded capital			
47	projects for informational purposes and these unfunded capital projects are supported by			
48	the City Commission and City Administration in the event funding is identified, including			
49	but not limited to, potential Utility Revenue Bonds, Broward County Surtax funding, State			
50	Appropriation Grant funding, etc.			
51	SECTION 4. All ordinances or portions of the Code of Ordinances of the City of			
52	Hallandale Beach in conflict with the provisions of this ordinance shall be repealed to the			
53	extent of such conflict.			
54	SECTION 5. Should any provision of this ordinance be declared by a court of			
55	competent jurisdiction to be invalid, the same shall not affect the validity of the ordinance			
56	as a whole, or any part thereof, other that the part declared to be invalid.			
57	SECTION 6. The provisions of this ordinance shall become effective immediately			
58	upon adoption.
