STAFF SUMMARY:											

Summary:

This item seeks City Commission approval to provide a driver for a Santa Sleigh visit to Gulfstream Early Learning Center on December 19th and a driver and Police escort for the annual Community Santa Sleigh ride on December 24th and waive the staffing fees for this use.

Background:

For many years, the Parks, Recreation and Open Spaces (PROS) Department has partnered with the Rotary Club of Hallandale Beach/ Aventura to use the Rotary's Santa Sleigh for our Holiday in the Park event. Each year, PROS takes the sleigh out of storage,

makes any minor repairs needed, then uses the sleigh to bring Santa to the City's Holiday celebration. The Rotary then uses the sleigh to spread holiday cheer and bring Santa to the Gulfstream Early Learning Center in December and for the annual Community Sleigh Ride on Christmas Eve where it visits families throughout the City.

Current Situation:

This year is the 63rd anniversary of Santa's Sleigh serving the Hallandale Beach community.

The Rotary is respectfully requesting the City provide a driver and Police escort for the sled on Christmas Eve, Wednesday, December 24th for approximately 6 hours as historically provided. They also request the sleigh be brought to the Gulfstream Early Learning Center on December 19th for their holiday event.

They are requesting the City waive the staff fees as follows:

Truck/ Driver for Christmas Eve	\$ 360	(OT \$60/hr x 6 hrs)
Police Escort for Christmas Eve	\$ 390	(On duty \$65/hr x 6 hrs)
Truck/ Driver for Gulfstream ELC	<u>\$ 150</u>	(Reg \$40/hr x 3.5 hrs)

Why Action is Necessary:

Waiver of staff fees is requested for the driver and Police escort.

Cost Benefit:

The annual event spreads holiday cheer throughout the community in a cost effective manner and promotes partnerships with local organizations such as the Rotary Club or Hallandale Beach.

PROPOSED ACTION:

The City Commission discuss and approve the use of City staff to drive the Santa Sleigh and provide a Police escort.
