RESOLUTION NO. 2023-

A RESOLUTION OF THE MAYOR AND CITY COMMISSION
OF THE CITY OF HALLANDALE BEACH, FLORIDA,
APPROVING THE INTERLOCAL AGREEMENT BETWEEN
THE CITY OF HALLANDALE BEACH AND THE
HALLANDALE BEACH COMMUNITY REDEVELOPMENT
AGENCY RELATING TO THE PROVISION OF DIRECT
SERVICES IN THE FORM OF ADDITIONAL CODE
COMPLIANCE SERVICES FOR FISCAL YEAR 2023-2024;
AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Hallandale Beach Community Redevelopment Agency (HBCRA)
desires to enter into an agreement with the City of Hallandale Beach to enhance Code
Compliance Services to promote greater voluntary compliance of code violations in the CRA;
and

WHEREAS, the HBCRA agrees to pay for an additional code compliance specialist to
respond to complaints of possible code violations in a timely and effective manner in order to
maintain a higher quality standard of living within the CRA; and

WHEREAS, Staff recommends that the Mayor and City Commission approve an
Interlocal Agreement between the HBCRA and the City for direct costs relating to additional
Code Compliance Services for Fiscal Year 2023-2024 in an amount not to exceed One
Hundred Six Thousand One Hundred Fifty Six Hundred and 00/100 Dollars (\$106,156.00).

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

SECTION 1. The Mayor and City Commission hereby approve an Interlocal
Agreement between the HBCRA and the City for direct costs relating to additional Code
Compliance Services for Fiscal Year 2023-2024 in an amount not to exceed One Hundred
Six Thousand One Hundred Fifty Six Hundred and 00/100 Dollars (\$106,156.00)., and
authorize the City Manager to execute all relating documents.

SECTION 2. Effective Date. This Resolution shall take effect immediately upon its
passage and adoption.
