25		WHEREAS, this proposed budget amendment is still within the allotted time
26	pursua	ant to Florida Statutes; and
27 28		WHEREAS, the City Administration proposes that the FY 2024-2025 adopte
29 30	budge	t be amended to include the following transactions:

75	SECTION 2. Adoption of Budget Amendment. The Mayor and City	
76	Commission hereby adopt the budget amendment to the FY 2024-2025 adopted budget	
77	as set forth in Attachments A of this ordinance.	
78 79	SECTION 3. Conflict. All ordinances, parts of ordinances, resolutions, or parts	
80	of resolutions in conflict herewith are hereby repealed, to the extent of the conflict.	
UU	or resolutions in commet herewith are hereby repealed, to the extent of the commet.	

81 82	SECTION 4. Severability. Should any provision of this Ordinance be declared by
83	a court of competent jurisdiction to be invalid, such decision shall not affect the validity of
84	this Ordinance as a whole or any portion thereof, other than the part that is declared to be
85	invalid.

87	SECTION 5. Effective Date. This Ordinance shall take effect immediately upon
88	adoption.
