19	WHEREAS, there has been increased interest in backyard and community food				
20	production to provide local food sources for communities nationwide; and				
21	WHEREAS, other communities within Florida and throughout the United States have				
22	been enacting compatible regulations to allow for the keeping of backyard chickens in urbar				
23	residential settings; and				
24	WHEREAS, the City Commission of the City of Hallandale Beach ("City Commission")				
25	has directed staff to explore circumstances and regulations for the keeping and raising of				
26	chickens within the limits of the City of Hallandale Beach, Florida ("City"); and				
27	WHEREAS, pursuant to the Animal Control regulations set forth in Chapter 6 of the City				
28	Code of Ordinances (the "Code"), the keeping of cattle, horses, swine, sheep, goats or poultry,				
29	including chickens, roosters and fowl are prohibited; and

30	WHEREAS, the City Commission recognizes the desire of all residents to live in a clean				
31	neighborhood environment free of excessive odor, noise, vermin and disease; and				
22	WHEREAS, due to soaring egg prices and grocery store purchasing limits resulting from

33	a bird flu pandemic, the City Commission has recognized the need to provide another local,				
34	homegrown solution for fresh eggs; and				

35	WHEREAS, the City Commission desires to enact a two-year pilot program to allow City				
36	staff to assess the backyard chicken program and subsequently determine whether to make the				
37	program permanent; and				
38	WHEREAS, City staff has proposed amendments to the City's animal control				
39	regulations to provide regulations for the keeping of backyard chickens within single-family				
40	and duplex residential zoning districts in the City; and				
41	WHEREAS, Staff recommends that the Mayor and City Commission consider the				
42	proposed amendments to the Code, as more specifically set forth below; and				
43	WHEREAS, the Mayor and City Commission recognize that the proposed amendments				
44	are in the best interests of the health, safety and welfare of the City and its residents.				
45	NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COMMISSION				
46	OF THE CITY OF HALLANDALE BEACH, FLORIDA:				
47	SECTION 1 . Incorporation of Recitals . The foregoing "Whereas" clauses are				
48	confirmed as true and incorporated herein.				
49	SECTION 2. Amendment. The following sections within Chapter 6, Article I,				
50	Division I of the City of Hallandale Beach Code of Ordinances are hereby amended as follows:

53 54	ARTICLE I. – IN GENERAL				
55	Sec. 6-3 Keeping cattle, horses or poultry prohibited; exceptions.				
56 57 58 59 60	It shall be unlawful for any person to keep any cattle, horses, swine, sheep, goats or poultry within the city, except as otherwise specifically permitted by Code. This section shall not be construed to prohibit the operation of a zoo or circus or similar activity or any farm or agricultural establishment that is properly licensed and permitted and operating in full compliance with all applicable federal, state, and local laws and regulations.

Sec. 6-3.1. General Regulations and Conditions for Keeping of Backyard Chickens.

Intent. It is the intent of this section to establish and implement an urban backyard chicken program, thereby allowing residents to keep or raise chickens on a developed and occupied single-family or duplex property within a residential zoning district, subject to the regulations and conditions set forth in this section. Any person keeping chickens as an accessory to an occupied residential single-family or duplex dwelling shall be subject to the following restrictions:

(a) General Regulations.

- (1) For the purposes of this section, the term "chicken" refers to female chickens only (i.e., hens).
- (2) The maximum number of chickens allowed per property will be four (4) hens.
- (3) The keeping of roosters within any zoning district within the City is prohibited. Any chicken that crows shall be deemed a rooster for the purposes of this Code.
- (4) This section shall not authorize persons to violate applicable restrictive covenants and provisions of homeowners' association rules and regulations. Homeowners are solely responsible for compliance with all applicable restrictive covenants and homeowners' association rules and regulations.
- (5) The keeping of chickens under these regulations shall not be considered a "farm" nor considered the process of "farming."
- (6) Chickens permitted under this section must be kept for personal use only. Selling chickens, eggs, feathers, chicken manure, or other chicken products, and/or the breeding of chickens is hereby prohibited.
- (7) Slaughtering of chickens is prohibited on the homeowner's property.
- (8) Chickens kept under this section must be provided with adequate food and water to sustain a healthy life.
- (9) Chicken feed shall be stored in an enclosed container sufficient to protect such feed from rodents or other pests.
- (10) Chickens shall not be allowed to run free without direct personal supervision, and in such cases shall only be allowed within owner's fenced in-yard.
- (11) <u>In order to keep chickens, property owners shall apply for and receive a permit from the City pursuant to this section.</u>

(b) Backyard Chicken Coop and Accessory Structures.

(1) Permit Required. A Backyard Chicken permit (hereinafter "permit"), is required for the keeping of chickens. The permit is personal to the permittee and may not be assigned. If the person applying for the permit is not the fee simple owner of the subject property, the fee simple owner must provide owner authorization and consent to the application. The fee for the permit will be set by Resolution of the City Commission.

Upon receiving a permit from the City under this section, up to four (4) chickens 103 may be kept at an occupied, detached single family residence located within a single-104 family residential zoning district. 105 Ducks, geese, turkeys, peafowl, male chickens/roosters, pigeons, or any other 106 poultry or fowl are not allowed under this program and are strictly prohibited. 107 Chickens are not allowed on triplex, townhomes, multifamily properties, 108 community gardens, or any other uses. 109 Chickens must be secured within a covered chicken coop, chicken tractor, or 110 fenced pen/run area at all times and are not allowed to run at large upon any public 111 properties or off the premises of the owner. The coop and pen/run area must be 112 completely secured from predators with hardware cloth or similar material. Chicken 113 wire shall not be used. 114 115 Chicken coops and related accessory structures shall only be located in the backyard and subject to rear yard setbacks and other applicable City regulations. 116 No manure may be allowed to accumulate on the floor of the coop or ground. (7) 117 Composting of chicken manure is allowed only within an enclosed bin. The (8)118 composting bin shall be kept at least 20 feet away from all property lines. 119 120 (c) Nuisance. 121 Any violations of this Section may be enforced in accordance with Section 6-8 122 of the City Code. Additionally, the Development Services Director has the discretion 123 to revoke the permit and require that the chickens be removed within ten (10) days if 124 he or she determines that the permittee is in violation of the requirements of the 125 section. 126 Chickens shall not run free off the permitted property or be found at large and 127 shall not damage property or deposit excrement upon property belonging to anyone 128 129 other their owner. The coop and pen/run area must be cleaned regularly and kept free of insects 130 and rodents. Odors from chickens, chicken manure, or other items associated with the 131 keeping of chickens must not be perceptible at the property boundaries. Chickens 132 must not be permitted to create a nuisance consisting of noise or pests or contribute 133 to any other nuisance condition. 134 All feed and other items associated with the keeping of chickens that are likely 135 to attract or to become infested with flies, rodents or other pests shall be kept in a 136 rodent and pest-proof container. 137 The urban backyard chicken program will expire two (2) years from its adoption 138 on or about on 2027, unless otherwise extended by the City 139 Commission. 140
