SHORT TITLE:

AN ORDINANCE OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDING RFP FY#2022-2023-001, FRANCHISE TOWING SERVICES, TO WESTWAY TOWING, INC. TO PROVIDE CITYWIDE TOWING SERVICES; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A FRANCHISE AGREEMENT WITH WESTWAY TOWING, INC.; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

Staff seeks approval to award the Citywide Towing Services RFP # FY 2022-2023-001, to the highest ranked firm Westway Towing, Inc. Pursuant to Chapter 28, Article V, Section 28-172,

Towing Franchise, of the City of Hallandale Beach Code of Ordinances, the City Commission will allow a private towing agency to provide towing services for all damaged, disabled, and abandoned motor vehicles. Towing services agreement is an agreement between the City and a towing business that authorizes the towing business to provide services for private vehicles or vessels ordered towed by the City, within the limits of the City, and during designated periods of time. Should negotiations with the highest ranked firm be unsuccessful, authorize the City Manager and City Attorney to negotiate with the second highest ranked firm, A Superior Towing Company. There is no cost to the City as this is a revenue generating contract.

Background:

The City currently utilizes Mac's Towing Service for Citywide Towing Services. Mac's Towing Service replaced AAAA Crosstown Towing, Inc. whose contract was terminated in November 2022. The termination of AAAA Crosstown Towing, Inc.'s contract was after multiple attempts were made to collect past due payments to the City. In the interim, a contract was completed with Mac's Towing Service until the completion of the RFP for City Wide Towing Services.

During the RFP, via Ordinance 2023-001, the City Commission approved the amendment of Article 1 Section 28-7, towing by private companies, to increase the distance tow companies can store vehicles from 5 miles to 10. This increased the number of viable vendors for the RFP.

Current Situation:

The release notice for the RFP was sent via email to over four hundred (400) vendors including vendors from the City's Vendor list and pertinent vendors that have a City Business Tax License to operate in the City.

Staff evaluated the responses and determined that Westway Towing, Inc. is the highest ranked firm. Staff concurs with the Evaluation Committee's recommendation to award the Franchise Towing Services to Westway Towing, Inc.

Why Action is Necessary:

Pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000.00 shall be based on competitive bids. Furthermore, pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager shall have the authority to recommend to the City Commission award of contracts. Additionally, Section 5.01(4)(d) of the City Charter requires a franchise be granted by ordinance.

Cost Benefit:

Based on state regulated tow charges the annual revenue expected from towing services is \$24,000, or \$120,000 over the life of the five (5) year contract.

PROPOSED ACTION:

Staff recommends the approval on first reading of the attached Ordinance.
