22	installed by Acolite Claude United Sign Co., Inc. in 2014 and has, over the past decade,
23	deteriorated and requires extensive refurbishment to renew the appearance and ensure the
24	proper operation of its pumps and internal systems; and

26	WHEREAS, on February 16, 2023, the City released Bid # FY 2022-2023-007, to
27	Refurbish City of Hallandale Beach (COHB) Gateway Monument to select the most qualified
28	contractor(s); and

WHEREAS, Staff recommends that the Mayor and City Commission award Bid # FY 2022-2023-007, to Refurbish City of Hallandale Beach's Gateway Monument to Acolite Claude United Sign Co., Inc., as the lowest responsive bidder in an amount not to exceed One Hundred Twenty-Seven Thousand, Six Hundred, Ninety- Seven Dollars (\$127,697), and authorize the City Manager to execute all related documents.
