PREMIUM MOBILITY PLAN (PREMO) UPDATE.

STAFF SUMMARY:

Summary:

This is a presentation by Broward County Transit (BCT) providing the City Commission with an update on the County's Premium Mobility Plan (PREMO). Broward County is not requesting any formal action or Resolution by the City Commission at this time.

Background:

With funding made possible through the voter approved one-cent surtax for transportation, and in close coordination with Broward Public Works, Florida Department of Transportation, and municipal partners, Broward County Transit (BCT) is studying transit needs to create the Premium Mobility Plan, or PREMO, a proposed network of countywide premium transit that is convenient, attractive, safe, reliable, and frequent. The PREMO plan includes a combination of Light Rail

Transit (LRT), Bus Rapid Transit (BRT), and High Frequency Transit. County staff will provide an update on the process to develop PREMO and the outcomes/initial recommendations from the May Broward County Board of County Commissioners Transportation Workshop.

In addition, the team will show how Broward residents will be able to see plans and weigh in on the proposal via the PREMO website where residents and visitors can view the PREMO plan, learn more about premium transit modes, take a survey, and provide feedback.

Current Situation:

BCT is not asking for any formal resolution of support currently.

Why Action is Necessary:

This is a presentation to the City Commission for public information.

Cost Benefit:

PREMO is a County initiative funded by the Broward Transportation Surtax revenues. There is no proposed cost burden on the City.

PROPOSED ACTION:

There is no action requested by the City Commission at this time. BCT will be available to answer questions from the City Commission
