#### **SHORT TITLE:**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING AWARD OF BID # FY 2022-2023-007 TO REFURBISH THE CITY'S GATEWAY MONUMENT TO ACOLITE CLAUDE UNITED SIGN CO., INC. AS THE LOWEST RESPONSIVE BIDDER IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY-SEVEN THOUSAND, SIX HUNDRED, NINETY-SEVEN DOLLARS (\$127,697); AND PROVIDING AN EFFECTIVE DATE.

#### **STAFF SUMMARY:**

#### **Summary:**

Staff seeks approval of the attached resolution awarding BID # FY 2022-2023-007, for Refurbish City of Hallandale Beach (COHB) Gateway Monument to Acolite Claude United Sign Co., Inc. the lowest responsive bidder at \$127,696.75 and authorizing the City Manager to execute all related documents to effectuate the agreement.

#### **Background:**

The City's main gateway entrance signage was completed in 2014. The signage was originally fabricated and installed by Acolite Claude United Sign Co., Inc. Over the years, the sign has deteriorated and now requires extensive refurbishment to renew the appearance and ensure the proper operation of the pumps and internal systems.

#### **Current Situation:**

The City released Bid # FY 2022-2023-007, for Refurbish City of Hallandale Beach (COHB) Gateway Monument on February 16, 2023 to select the most qualified contractor(s). The purpose of Bid # FY 2022-2023-007 was to establish a contract to supply all labor, equipment, tools, and materials from qualified and certified Contractors to refurbish the gateway fountain.

The release notice for the BID was sent via email to over one thousand four hundred (1,400) vendors including vendors from the City's Vendor list and pertinent vendors that have a City Business Tax License to operate in the City. In addition, the BID was advertised in the Hallandale Beach Chamber of Commerce website, City's website, DEMANDSTAR website, and Official City Social Media pages. The BID was also advertised through the Miami Minority Business Development Agency Business Center, the U.S. Small Business Administration, and the Broward County Community Relations and Outreach Section Office of Economic and Small Business Development.

On February 27, 2023, a mandatory pre-bid meeting was held at City Hall Commission Chambers and a mandatory site visit. Two (2) firms attended the pre-bid meeting and site-visit. The Bid allowed for additional questions to be sent via email by no later than March 6, 2023. The bid responses were due March 23, 2023 at 11:00 am. The City received two (2) bids.

Staff has reviewed the bids and the attached Award Recommendation Memorandum (Exhibit 3) and recommends awarding Bid # FY 2022-2023-007, for Refurbish City of Hallandale Beach (COHB) Gateway Monument to Acolite Claude United Sign Co., Inc.

#### Why Action is Necessary:

Pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000.00 shall be based on competitive bids. Furthermore, pursuant to Chapter 23, Section 23-

6, Award of Contract, the City Manager, shall have the authority to recommend to the City Commission award of contracts.

#### **Cost Benefit:**

The award of this contract will ensure the vibrant appearance of the Gateway signage and proper operation of the fountain and internal systems.

The City Commission approve the attached resolution.
