24	WHEREAS, Staff recommends construction of new storm drainage facilities to
25	improve flooding nuisance along NE 3 <sup>rd</sup> Street from NE 1 <sup>st</sup> Avenue to NE 2 <sup>nd</sup> Avenue,
26	pavement restoration and markings, regrading and sodding of swales as necessary,
27	sidewalk replacement, new ADA ramps as required, removal and replacement of vegetation,
28	waterline relocation, and other miscellaneous improvements; and

30	WHEREAS, on November 3, 2022, BID # FY 2022-2023-003 NE 3rd Street Drainage
31	Mitigation Project was released; and

33	WHEREAS, the Department of Public Works recommends that the Mayor and City

35	Basile USA LLC, the lowest responsive bidder, in the amount of One Million, Seventeen

37	contingency of ninety six thousand seven hundred and ninety dollars (\$96,790), for a total

51	hundred and ninety dollars (\$96,790), for a total not to exceed amount of One Million, One
52	Hundred Fourteen Thousand, Two Hundred, Ninety-Six Dollars and Seventy-Seven Cents
53	(\$1,114,296.77), and authorize the City Manager to sign all related documents.
